## SET HEARING FOR THE VACATION AND CONVEYANCE OF AN ENCROACHMENT EASEMENT ADJOINING 301 EAST COURT AVENUE TO EAST VILLAGE COURT. LLC FOR \$395

Commencing at the Southwest corner of said Lot 4; thence North 12°(degrees) 35'(minutes) 37"(seconds) West, along said East R.O.W. line of East 3<sup>rd</sup> Street, a distance of 49.38 feet, to the Point of Beginning; thence South 77°33'36" West, 3.50 feet; thence North 12°35'37" West, along a line parallel with said East R.O.W. line of East 3<sup>rd</sup> Street, a distance of 20.50 feet; thence North 77°33'36" East, 3.50 feet, to a point on said East R.O.W. line of East 3<sup>rd</sup> Street; thence South 12°35'37" East, along said East R.O.W. line of East 3<sup>rd</sup> Street, a distance of 20.50 feet, to the Point of Beginning, containing 71.75 sq. ft., more or less.


