SET DATE OF HEARING FOR APPROVAL OF AMENDMENT TO CURRENT OPERATING AGREEMENT WITH AMERICAN EAGLE AIRLINES INC., EXTENDING THEIR SCHEDULED AIRLINE OPERATING AGREEMENT AND TERMINAL BUILDING LEASE AT THE DES MOINES INTERNATIONAL AIRPORT UNTIL JUNE 30, 2008

WHEREAS, the City of Des Moines owns and operates an airport known as Des Moines International Airport (hereinafter called the "Airport"), located in Des Moines, Polk County, Iowa; and

WHEREAS, on September 20, 1993, by Roll Call No. 93-3490, the Des Moines City Council approved Ordinance 12,040 assigning certain rights and responsibilities pertaining to the Airport to the Des Moines International Airport Board (hereinafter called the "Board"), including the right to enter into leases up to three years in duration and certain other agreements; and

WHEREAS, on February 3, 2004, by Resolution No. A04-25, the Airport Board approved the assignment of the Original Agreement to American Eagle Airlines, Inc. (Airline); and

WHEREAS, on December 7, 2004, by Resolution No. A04-244, the Airport Board approved the First Amendment to the Scheduled Airline Operating Agreement And Terminal Building Lease (hereinafter called the "First Amendment") between the City and Airline; and

WHEREAS, the First Amendment to the Original Agreement was scheduled to terminate on June 30, 2006; and

WHEREAS, on May 2, 2006, by Resolution A06-84, the Des Moines International Airport Board recommended staff negotiate and present to City Council amendments extending the terms of the current Signatory Agreements until June 30, 2008; and

WHEREAS, American Eagle Airlines Inc. has returned a SECOND AMENDMENT TO SCHEDULED AIRLINE OPERATING AGREEMENT AND TERMINAL BUILDING LEASE extending the term of the original Signatory Agreement until June 30, 2008; and

WHEREAS, the SCHEDULED AIRLINE OPERATING AGREEMENT AND TERMINAL BUILDING LEASE term with Amendment(s) will be greater that three years, which therefore requires a public hearing and City Council approval, NOW, THEREFORE,
