## SETTING DATE OF PUBLIC HEARING ON THE PROPOSED EIGHTH AMENDMENT TO THE METRO CENTER URBAN RENEWAL PLAN

WHEREAS, on March 20, 2000, by Roll Call Nos. 00-788 and 00-789, the City Council adopted the Urban Renewal Plan for the Metro Center Urban Renewal Project, and such Plan has been amended seven times (the urban renewal plan as so amended is herein referred to as the "Plan"); and,

WHEREAS, the Metro Center Urban Renewal Project Area encompasses an irregularly shaped area that includes the downtown core and the areas surrounding the downtown core; and,

WHEREAS, the purpose of the proposed Eighth Amendment to the Plan, attached hereto as Exhibit "A", is to:

- a) Update the Zoning Map to reflect the new "D-R" Downtown Riverfront zoning district and other zoning changes;
- b) Update the Public Improvements Map and appropriate text to reflect additional public projects to be undertaken, including: various public parking garages, public bridges, and street improvements;
- c) Revise the existing language regarding urban renewal construction tax abatement for qualifying large-scale projects;
- d) Update the Neighborhood Map to reflect the currently recognized neighborhoods;
- e) Update the Disposition Map; and,
- f) Update the Financial Report.

WHEREAS, the Urban Design Review Board may review the proposed amendment at its regular meeting of May 1, 2007, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council; and,

WHEREAS, the City Plan and Zoning Commission may review the proposed amendment at its regular meeting on May 3, 2007, and should be prepared to submit its report and recommendation to the City Council before the date proposed for public hearing by the City Council; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

1. A public hearing shall be held before the City Council to consider the proposed Eighth Amendment to the Plan at 5:00 p.m. on May 21, 2007, in the City Council Chamber, City Hall, 400 East First Street, Des Moines, Iowa.
