Box 394, Johnston, IA, 50131-0394 - as Contractor, and Tasty Tacos, Inc., Linda Mosqueda-Blair, President, 1418 E Grand Ave, Des Moines, IA, 50316 - as Owner, for construction of Paving Improvements described as Turn Lane construction North of E. Diehl Avenue on the East side of SE 14th Street to serve Tasty Tacos at 5847 SE 14th Street, Des Moines, IA, per Plan File No. 455-104, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.


