APPROVING SUBGRANT AGREEMENT AND ADDENDUM WITH IOWA HOMELAND SECURITY AND ENERGY MANAGEMENT DIVISION FOR FEMA GRANT TO ENHANCE GEOGRAPHIC INFORMATION SYSTEMS (GIS) TO SUPPORT HAZARD RISK ASSESSMENT AND AUTHORIZING CITY MANAGER TO EXECUTE SAID GRANT ADDENDUM

WHEREAS, on January 16, 2008 the City of Des Moines was notified of its eligibility to receive a federal appropriation under the FEMA Pre-Disaster Mitigation (PDM) Program for risk identification, planning, communication, response coordination, and modeling activities for disaster mitigation; and

WHEREAS, the funding was to be disbursed through FEMA in the form of a subgrant through Iowa Homeland Security and Emergency Management Division (IHSEMD); and

WHEREAS, on March 13, 2008, the City of Des Moines Information Technology (IT) Department submitted a subgrant application for funding to strengthen the Des Moines Area Regional Geographic Information System (Regional GIS) to aid effective decision-making related to pre-disaster mitigation; and

WHEREAS, on September 4, 2008, FEMA awarded the City a subgrant in the amount of \$198,836.79 for the project; and

WHEREAS, on November 25, 2008, IHSEMD presented IT Department staff with a subgrant agreement for said grant and it has been recently discovered that this agreement was inadvertently not brought to the City Council for acceptance and authorization to execute it; and

WHEREAS, IHSEMD has provided the City an Addendum to the original subgrant agreement to confirm the City's approval of the grant agreement.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines Iowa that the above described grant agreement and Addendum, a copy of which are on file in the City Clerk's Office, are hereby approved and the City Manager is hereby authorized and directed to execute the Addendum on behalf of the City to accept a subgrant from FEMA through the Iowa Homeland Security and Energy Management Division for \$198,836.79.
