HOLD HEARING FOR THE LEASE OF A PORTION OF EWING PARK WITH EWING PARK BMX CLUB AND AUTHORIZING THE CITY MANGER TO EXECUTE THE SAME AND ONE FIVE YEAR RENEWAL

WHEREAS, on April 6, 2009, by Roll Call 09-**<u>5</u>***H*, it was duly resolved by City Council that the proposed lease of a portion of Ewing Park, as more specifically described below, be set down for hearing on April 6, 2009 at 5:00 pm in the Council Chamber; and,

WHEREAS, due notice of said proposal to lease public real property interests was given as provided by law, setting forth the time and place for hearing on said proposal; and

WHEREAS, in accordance with said notice, those interested in said proposed lease, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. Upon due consideration of the facts and statements of interested persons, the objections to said proposed lease of public real property as described below are hereby overruled and the hearing is closed.

2. There currently is no public need for the property to be leased and the public would not be inconvenienced by reason of the lease of the below described property in Ewing Park to the Ewing Park BMX Club.

3. The lease of the below described property to the Ewing Park BMX Club for an annual rental fee of \$30.00 plus the Club's performance of maintenance on the property, for a period of five (5) years with a five (5) year renewal option be and is hereby approved:

The North 389.0 feet of the West 560.0 feet of Lot 3 of the Official Plat of the Northwest ¹/₄ of Section 26, Township 78 North, Range 24 West of the 5th P.M.; all now included in and forming a part of the City of Des Moines, Polk County, Iowa. (Approximately 217,840 SQ FT 5 Acres).

Except Park Access Road lying West of the East line of Park Access Road.

4. The City Manager is authorized and directed to sign the lease agreement as identified above, and the renewal agreement after the initial term of this lease, and the City Clerk is authorized and directed to attest to the City Manager's signature.
