**HOLD HEARING FOR CONVEYANCE OF CITY-OWNED PROPERTY LOCATED AT SOUTHWEST CORNER OF JARVIS STREET AND KEYES DRIVE TO DOUGLAS S. BROWER AND MARSHA L. DUEA FOR \$1,000**

**WHEREAS**, the City of Des Moines is the owner of excess property located at the southwest corner of Jarvis Street and Keyes Drive, which property is legally described below; and

**WHEREAS**, the conveyance of the City-owned real property located at the southwest corner of Jarvis Street and Keyes Drive was solicited by a competitive disposition process to adjoining property owners for sideyard use; and

**WHEREAS**, Douglas S. Brower and Marsha L. Duea are the owners of property abutting the City-owned property at the southwest corner of Jarvis Street and Keyes Drive, and have offered to the City of Des Moines the purchase price of \$1,000.00 for the purchase of such City-owned property more specifically described below, which price was the highest bid received; and

**WHEREAS**, on April 6, 2009, by Roll Call No. 09-542, it was duly resolved by the City Council that the proposed conveyance of real property located at the southwest corner of Jarvis Street and Keyes Drive, be set down for hearing on April 20, 2009, at 5:00 p.m., in the City Council Chambers; and

**WHEREAS**, due notice of said proposal to convey this public real property was given as provided by law, setting forth the time and place for hearing on said proposal; and

**WHEREAS**, in accordance with City Council direction, those interested in this proposed conveyance, both for and against, have been given an opportunity to be heard with respect thereto and have presented their views to the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa:

1. Upon due consideration of the facts and statements of interested persons, the objections to the proposed conveyance of this property, as described below, are hereby overruled and the hearing is closed.

2. There is no public need for the property described below and the public would not be inconvenienced by reason of the conveyance of this property located at the southwest corner of Jarvis Street and Keyes Drive, more specifically described as follows:

Lots 316 and Lot 317 WATROUS PARK, Plat 2, an Official Plat, now included in and forming a part of the City of Des Moines, Polk County, Iowa.

3. That the sale and conveyance of such City-owned property to Douglas S. Brower and Marsha L. Duea for \$1,000.00, together with payment by such grantee of the estimated publication and recording costs for this transaction, be and is hereby approved.

The City Clerk is authorized and directed to forward the original of this Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Real Estate Division of the Engineering Department for the purpose of causing said documents to be recorded.
6. The Real Estate Division Manager is authorized and directed to forward the original of the Deed, together with a certified copy of this resolution and of the affidavit of publication of the notice of this hearing, to the Polk County Recorder's Office for the purpose of causing these documents to be recorded.
7. Upon receipt of the recorded documents back from the Polk County Recorder, the Real Estate Division Manager shall mail the original of the Deed and copies of the other documents to the grantee.
8. The proceeds from the sale of this property will be deposited into the following account: Property Maintenance Endowment Fund, SP767, ENG980500

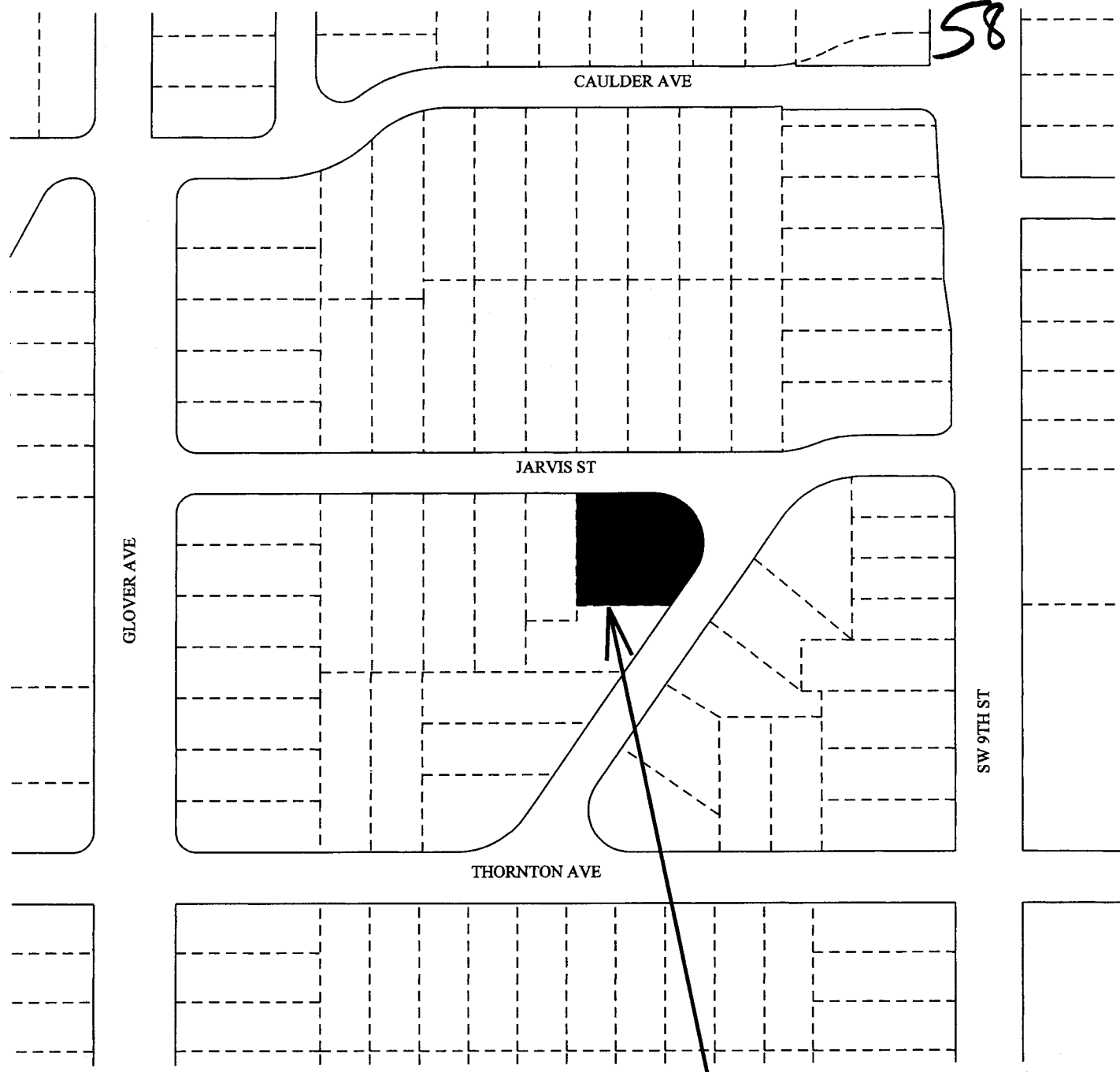

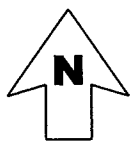
