SET HEARING FOR VACATION AND CONVEYANCE OF NORTH/SOUTH ALLEY BETWEEN 22ND STREET AND 23RD STREET FROM OLIVE AVENUE TO THE INTERSTATE 235 RIGHT-OF-WAY, TO ADJOINING PROPERTY OWNERS FOR \$100

WHEREAS, on May 21, 2007, by Roll Call No. 07-964, the City Council adopted a recommendation from the City Plan and Zoning Commission that the North/South alley right-of-way between 22nd Street and 23rd Street from Olive Avenue to the Interstate 235 right-of-way, hereinafter more fully described, be vacated and sold; and

WHEREAS, the grantees identified below are the owners of property abutting such right-of-way and have offered to the City of Des Moines the purchase price identified below for the vacation and purchase of the portion of such right-of-way described below.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

1. That the City Council of the City of Des Moines shall consider adoption of an ordinance permanently vacating the North/South alley right-of-way between 22nd Street and 23rd Street from Olive Avenue to the Interstate 235 right-of-way, more specifically described as follows:

All that part of the North/South alley right-of-way lying North of the easterly extension of the North right of way line of Olive Avenue and lying South of the easterly extension of the North line of the South 30.0 feet of Lot 39, Ira W. Andersons Cottage Grove Addition, an Official Plat. All now included in and forming a part of the City of Des Moines, Polk County, Iowa.

2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines proposes to sell such right-of-way, as described below to the grantees and for the consideration identified below:


