REPROGRAMMING OF PRIOR YEARS COMMUNITY DEVELOPMENT BLOCK GRANT
(CDBG) FUNDING TO BALANCE PROGRAM YEAR (PY) 2008 FUNDING SHORTFALL
AND CLOSEOUT 2006 NEIGHBORHOOD CONSERVATION SERVICES (NCS)
PROJECTS

WHEREAS, on November 19, 2007, by Roll Call No. 07-2231, the City Council held a public hearing regarding the 2008 HUD Consolidated Plan and authorized and directed the City Manager to submit the 2008 HUD Consolidated Plan to the U.S. Department of Housing and Urban Development; and

WHEREAS, on July 24, 2006, by Roll Call No. 06-1466, the City Council approved the carryover, budget amendment and administrative changes of CDBG funding for the 2006 NCS projects, to be spent by November, 2007; and

WHEREAS, of the above-referenced carryover funding, NCS has recently identified \$54,000 of CDBG funding committed for two Lead Base Paint Remediation projects for carryover to the 2008 Homeowner Rehabilitation Program, \$305,000 committed for two rehabilitation projects for carryover to the 2008 Investor Owner Rehabilitation Program and \$121,781 available for reprogramming; and

WHEREAS, the City's Neighborhood Revitalization Board (NRB) reviewed and approved recommendations for closeout of 2006 NCS projects, carryover to 2008 NCS projects and reprogramming of NCS CDBG funding to be applied toward the 2008 CDBG shortfall at their meeting of April 2, 2008; and

WHEREAS, the City Manager has reviewed unspent prior year CDBG funding and PY 2008 funding shortfall and is recommending that these funds be utilized as set out in the attached Council Communication No. 08-_____.
