APPROVING AN EXCEPTION TO THE PROCUREMENT ORDINANCE
COMPETITIVE PROCUREMENT REQUIREMENTS AND APPROVING PAYMENT
TO ENVIRONMENTAL SYSTEMS RESEARCH INSTITUTE FOR CONSULTING
SERVICES AND SERVER AND DESKTOP SOFTWARE FOR A REGIONAL
HOMELAND SECURITY GIS CENTRAL REPOSITORY AND AUTHORIZING CITY
MANAGER TO NEGOTIATE AND EXECUTE AGREEMENT FOR SAME

WHEREAS, the City of Des Moines has received a Federal Byrne Discretionary Grant in the amount of \$993,500.00 to establish a Regional Homeland Security central repository based on the Environmental Systems Research Institute ("ESRI") Homeland Security database model of geographical information; and

WHEREAS, the data model for the regional Geographical Information System ("GIS") will be based upon ESRI's Homeland Security Data Model; and

WHEREAS, such regional GSI repository will be centered in Des Moines and will serve the current regional GIS participants of the cities of West Des Moines, Urbandale, Clive, Johnston, Ankeny, Pleasant Hill and Waukee, Des Moines Police Department, Polk County Sheriff's Office, Polk County, and Public Safety Answering Points, and West Des Moines Westcom; and

WHEREAS, ESRI, 820 S. Main Street, St. Charles, MO 63301-3306, is the sole vendor and provider of the GIS software used by the ESRI Homeland Data Model; and

WHEREAS, Municipal Code section 2-726(a)(7) provides that the procurement of goods and/or services which are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing City needs, materials or equipment to be cost effective, and the City Manager so finds and declares in writing, may be exempt from the competitive bidding and advertising requirements of the Procurement Ordinance; and

WHEREAS, the City Manager recommends approval of the acquisition of the above described software and consulting services including implementation training from ESRI in an amount not to exceed \$250,000.00, and finds that the above-described software and services meet the requirements of Municipal Code section 2-726(a)(7) and should be exempted from the competitive procurement and advertisement requirements of the Procurement Ordinance; and
