2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines proposes to sell such right-of-way, as described below, to the grantee and for the consideration identified below:

To: Employers Mutual Casualty Company for \$85,608

All of the vacated Market Street right-of-way lying North of and adjoining West Martin Luther King, Jr. Parkway and lying South of and adjoining Block 5, Fort Des Moines, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.
