## ORDINANCE NO.

AN ORDINANCE vacating East Granger Avenue right-of-way from SE 34<sup>th</sup> Street to SE 37<sup>th</sup> Street, SE 34<sup>th</sup> Street right-of-way from East Granger Avenue to Vandalia Road, SE 35<sup>th</sup> Street right-of-way from East Granger Avenue to Vandalia Road, and SE 37<sup>th</sup> Street right-of-way from vacated Wabash Railroad to Vandalia Road.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That East Granger Avenue right-of-way from SE 34<sup>th</sup> Street to SE 37<sup>th</sup> Street, SE 34<sup>th</sup> Street right-of-way from East Granger Avenue to Vandalia Road, SE 35<sup>th</sup> Street right-of-way from East Granger Avenue to Vandalia Road, and SE 37<sup>th</sup> Street right-of-way from vacated Wabash Railroad to Vandalia Road, more specifically described as follows, be and is hereby vacated.

Lot B (now known as Southeast 37<sup>th</sup> Street), Lot E (now known as East Granger Avenue, also known as Granger Avenue and formerly known as Edison Avenue), all in Vandalia Acres, an Official Plat; and Lot A (now known as Southeast 34<sup>th</sup> Street), Lot B (now known as Southeast 35<sup>th</sup> Street), and part of Lot D (now known as East Granger Avenue and also known as Granger Avenue) from the northerly extension of the West line of said Lot A to the northerly extension of the East line of said Lot B, all in Vandalia Acres Plat No. 2, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

Sec. 2. The City of Des Moines hereby reserves an easement upon the property described above for the continued use and maintenance of any utilities now in place, with the right of entry for servicing same.

Sec. 3. That the City Clerk is hereby authorized and directed to cause certified copies of this ordinance and proof of publication thereof together with proof of publication of the notice of the public hearing on this matter to be properly filed in the office of the Recorder of Polk County, Iowa.

Sec. 4. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
