WHEREAS, on July 26, 2004 under Roll Call No. 04-1537, the City Council approved a private construction contract in the amount of \$170,150.00, between Van Hauen & Associates, Inc., Mark Van Hauen, CEO/Vice President, 13185 Pineview Drive, Clive, IA, 50325 - as Contractor, and Erickson Development, Inc., Tim Erickson, President, 3010 E Pine Avenue, Des Moines, IA, 50320 - as Owner, for construction of Sanitary Sewer Improvements described as construction of sanitary sewer improvements to serve the proposed Three Lakes Estates Plat 6 Development located at Three Lakes Parkway, Sweetwater Dr., Brockway Dr., Lake Hill Dr., and SE 30th Street, Des Moines, IA, per Plan File Nos. 442-093/104, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.



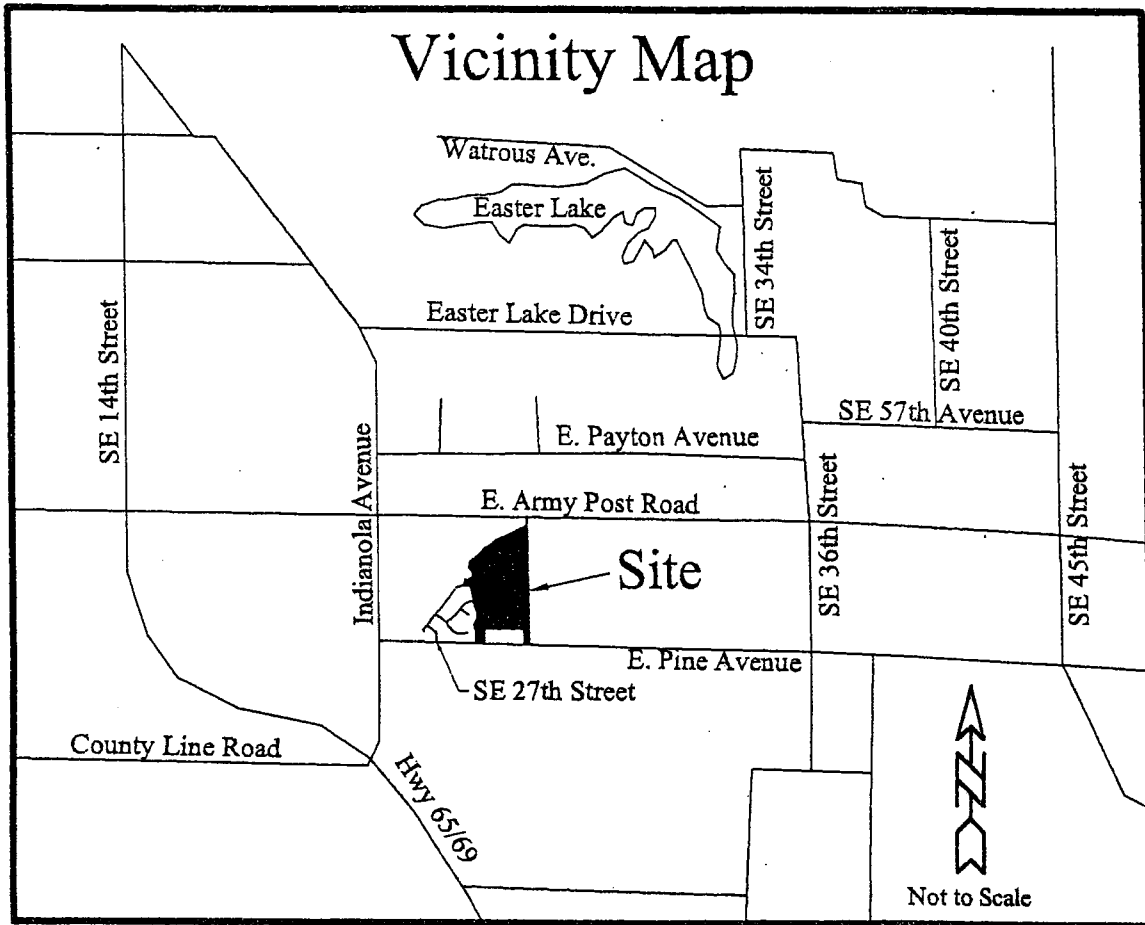
