RATIFYING COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) HAZARD MITIGATION GRANT PROGRAM MATCH FOR PROPERTY ACQUISITION CONTRACTS WITH IOWA DEPARTMENT OF ECONOMIC DEVELOPMENT, AND APPROVING AND AUTHORIZING EXECUTION OF CONTRACT AMENDMENTS THERETO

WHEREAS, the Hazard Mitigation Grant Program (HMGP) provides grants to State and local governments to implement long-term hazard mitigation measures after a Presidential disaster has been declared in order to implement measures during the recovery phase of a disaster to prevent damages in future disasters; and

WHEREAS, on September 19, 2008, the City of Des Moines submitted a Notice of Interest (NOI) to the Iowa Homeland Security & Emergency Management Division (IHSEMD) in order to be eligible for consideration to apply for HMGP funds; and

WHEREAS, on September 29, 2008, the City of Des Moines received a formal invitation to complete and submit an HMGP application; and

WHEREAS, on November 10, 2008, by Roll Call No. 08-2009, the City Council authorized submittal of HMGP Applications to the Federal Emergency Management Agency (FEMA) in order to fund a Voluntary Acquisition Program for eligible flood damaged propertied in the Four Mile Area; and

WHEREAS, on April 30, 2009, the City of Des Moines received notice that both grant applications had been approved by FEMA and HMGP Agreements were forwarded to the City for approval and execution; and

WHEREAS, on May 18, 2009, by Roll Call No. 09-842, the City Council of the City of Des Moines approved and authorized execution of the FEMA HMGP Grant Agreements; approved and authorized the HMGP Administrative Plan; and authorized voluntary property acquisition for the HMGP Voluntary Acquisition Project; and

WHEREAS, on July 13, 2009, by Roll Call No. 09-1284, the City Council of the City of Des Moines approved and adopted the Polk County Pre-Disaster Mitigation Plan as required by the FEMA Hazard Mitigation Grant Program to remain eligible under the grant for project expense reimbursement; and

WHEREAS, under the original grant and contract agreements, FEMA funds up to 75 percent of the HMGP mitigation project's total cost, 10 percent is funded by the State, and the remaining 15 percent is the responsibility of the City of Des Moines as the local applicant using federal Community Development Block Grant (CDBG) Disaster Relief funds administered by the Iowa Department of Economic Development (IDED); and

WHEREAS, IDED provided Contract Nos. 08-DRMH-016 and 08-DRMH-021 for approval and execution by the City of Des Moines for the Community Development Block Grant (CDBG) Hazard Mitigation Grant Program Match for Property Acquisition, which contracts awarded \$37,927 and \$124,463, respectively, in CDBG funding to the City for its local-match share of the FEMA Hazard Mitigation Grant Program; and

WHEREAS, IDED has now provided contract amendments to Contract Nos. 08-DRMH-016 and 08-DMRH-021 by which FEMA will continue to fund up to 75 percent of the HMGP mitigation project's total cost, and the 10 percent direct funding by the State is no longer available but has been replaced with a 25 percent local match funded using federal Community Development Block Grant (CDBG) Disaster Relief funds administered by the Iowa Department of Economic Development (IDED), with IDED providing additional CDBG funding to the City to cover said local-match increase in the amounts of \$24,908 and \$72,139, respectively, for new grant totals of \$62,835 and \$196,602.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

- 1. The Community Development Block Grant (CDBG) Hazard Mitigation Grant Program Match for Property Acquisition Contracts (Contract Nos. 08-DRMH-016 and 08-DRMH-021) between the City of Des Moines and the Iowa Department of Economic Development (IDED), as on file in the office of the City Clerk, and administration thereof are hereby ratified and approved.
- 2. The Mayor is authorized and directed to execute the contract amendments for Contract Numbers 08-DRMH-016 and 08-DMRH-021 and the City Clerk is hereby authorized and directed to deliver the aforementioned documents to the Real Estate Division Manager, who shall provide said amendments to IDED, and the Engineering Department is hereby authorized and directed to administer said Contracts and amendments thereto.


