**SET HEARING FOR CONVEYANCE OF EXCESS CITY-OWNED PROPERTY  
ADJOINING 3211 DELAWARE AVENUE TO DSDM, LLC FOR \$14,880**

**WHEREAS**, the City of Des Moines owns excess real property located east of 3211 Delaware Avenue (“Property), more particularly described below; and

**WHEREAS**, DSDM, LLC is the owner of property abutting said City-owned Property, and has offered to the City of Des Moines the purchase price of \$14,880 for the purchase of such Property in order to use it for expansion of and incorporation into their existing site, which conveyance will be subject to a no-build restriction over the eastern portion of the Property, and which price reflects the restricted fair market value of the property as currently estimated by the City’s Real Estate Division; and

**WHEREAS**, there is no known current or future public need for the Property proposed to be sold and the City will not be inconvenienced by the sale of said Property.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa proposes to sell the following described Property to DSDM, LLC for \$14,880:

The west 287.90 feet of the south 61.0 feet of Lot 26, Ovid Heights, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

2. A public hearing shall be held on May 10, 2010, at 5:00 p.m. in the City Council Chamber, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa. At that time the City Council will consider the above-described proposal and any other(s) submitted prior to or during the public hearing.
3. The City Clerk is hereby authorized and directed to publish notice of said proposal and hearing in the form hereto attached, all in accordance with Section 362.3 of the Iowa Code.
4. The proceeds from the sale of this property shall be deposited into the following account: 2010-2011 CIP, Page Storm Water Improvements - 4, City-wide Storm Water Utility Projects, STE057.

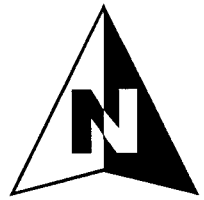
