ORDINANCE NO.

AN ORDINANCE vacating a portion of the east-west alley between Walker Street and Maple Street from East 14th Street to Johnson Court.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That a portion of the east-west alley between Walker Street and Maple Street from East 14th Street to Johnson Court, more specifically described as follows, be and is hereby vacated.

All of the east-west alley right of way lying west of the west right-of-way line of US Highway 69 (also known as Johnson Court, as presently established) and lying north of and adjoining Lots 4 through 13, Block 36, Stewart's Addition to the City of Des Moines, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.


Sec. 2. The City of Des Moines hereby reserves an easement upon the property described above for the continued use and maintenance of any utilities now in place, with the right of entry for servicing same.

Sec. 3. That the City Clerk is hereby authorized and directed to cause certified copies of this ordinance and proof of publication thereof together with proof of publication of the notice of the public hearing on this matter to be properly filed in the office of the Recorder of Polk County, Iowa.

Sec. 4. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
