RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSITION TO AUTHORIZE A SUPPLEMENT NO. D-2 TO THE GOVERNMENTAL LEASE-PURCHASE MASTER AGREEMENT BETWEEN THE CITY OF DES MOINES AND DE LAGE LANDEN PUBLIC FINANCE LLC, IN THE PRINCIPAL AMOUNT OF NOT TO EXCEED \$1,200,000, FOR THE PURPOSE OF ACQUIRING CERTAIN ITEMS OF EQUIPMENT AS DESCRIBED THEREIN AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, the City of Des Moines, Iowa (the "City") and De Lage Landen Public Finance have entered into a Governmental Lease-Purchase Master Agreement dated as of July 11, 2008 ("Master Agreement") relating to the acquisition by the City, from time to time, of certain items of equipment to be described in separate Supplements to said Master Agreement; and

WHEREAS, it is deemed necessary and advisable that the City should enter into a Supplement No. D-2 to the Master Lease in the principal amount of not of exceed \$1,200,000 (the "Supplement") as authorized by Sections 364.4 and 384.25 of the City Code of Iowa, for the purpose of providing funds to pay costs of acquiring the equipment as hereinafter described; and

WHEREAS, the term of the proposed Supplement will not exceed the economic life of the property to be acquired; and

WHEREAS, the proposed Supplement shall be payable from the Storm Water Enterprise Fund of the City of Des Moines, and the acquisition of the equipment is considered an "essential corporate purpose" under Section 384.24 of said Code; and

WHEREAS, before a lease-purchase agreement may be authorized, it is necessary to comply with the provisions of said Code, and to publish a notice of the proposal and of the time and place of the meeting at which the Council proposes to take action for the authorization of the lease-purchase agreement and to receive oral and/or written objections from any resident or property owner of said City to such action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

Section 1. That this Council meet in the Council Chambers, City Hall, Des Moines, Iowa, at 5:00 o'clock P..M., on the 18th day of May, 2009, for the purpose of taking action on the matter of the authorization of a Supplement to the Master Lease in the principal amount of not to exceed \$1,200,000, the proceeds of which will be used to provide funds to pay costs of acquiring up to seven street sweepers for the Public Works Department.

Section 2. That the Clerk is hereby directed to cause at least one publication to be made of a notice of said meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in said City, said publication to be not less than four clear days nor more than twenty days before the date of said public meeting on the authorization of said lease-purchase agreement.
