Approval of Advertising Concession Agreement with In-ter-space Services Inc. d/b/a Interspace Airport Advertising for Advertising and Display Services at the Des Moines International Airport

WHEREAS, the City of Des Moines owns and operates a facility commonly known as the Des Moines International Airport ("Airport"), located in Des Moines, Polk County, Iowa; and

WHEREAS, on March 3, 2004, by Resolution No. A04-38, the Airport Board approved a Concession Agreement with JCDecaux for the advertising and display services for the Des Moines International Airport for a period of three years expiring on June 30, 2007; and

WHEREAS, on February 14, 2007, a Request For Proposal (RFP) Bid No. V07-090 was advertised for the receipt of proposals for the Advertising and Display Service Concession at the Des Moines International Airport for a period of five years with an option for an additional five years; and

WHEREAS, on March 15, 2007, when the proposals were due, two proposals were received and were deemed by the City Purchasing Agent to be proper submissions; and

WHEREAS, the proposals submitted by In-ter-space Services Inc. d/b/a Interspace Airport Advertising ("Interspace") and International Airport Advertising LLC were both reviewed by staff and scored by the criteria outlined in the RFP document; and

WHEREAS, the proposal submitted by Interspace received the highest score by the review committee; and

WHEREAS, by its submission, Interspace has shown that it is qualified, ready, willing, and able to manage and operate the Airport Advertising and Display Concession; and

WHEREAS, on May 1, 2007 by Resolution A07-84, the Des Moines International Airport Board recommended City Council approval of Advertising and Display Service Concession Agreement with In-ter-space Services Inc. d/b/a Interspace Airport Advertising; and

WHEREAS, the Agreement is for a term greater than three years and therefore requires approval by the Des Moines City Council; and NOW THEREFORE ;
