ORDINANCE NO. _____

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,057, passed February 18, 2002, by amending Sections 114-3126 and 114-3323, relating to traffic regulation changes.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,057, passed February 18, 2002, is hereby amended by amending Sections 114-3126 and 114-3323 relating to traffic regulation changes, as follows:

Sec. 114-3126. East Creston Avenue--South Union Street to King Avenue.

East Creston Avenue, on the south side, from South Union Street to a point 50 feet east thereof, no parking any time.

East Creston Avenue, on the north side, from South Union Street to East Indianola Avenue, no parking any time.

East Creston Avenue, on the south side, from a point 1,350 feet east of South Union Street to a point 260 feet east thereof, no parking any time.

East Creston Avenue, on the north side, from Southeast Fourteenth Street to a point 50 feet east thereof, no parking any time.

East Creston Avenue, on the south side, from Southeast Fourteenth Street to Southeast Seventeenth Street, no parking any time.

East Creston Avenue, on the north side, from Southeast Eighteenth Court to King Avenue, no parking any time.

East Creston Avenue, on the north side, from King Avenue to a point 100 feet west thereof, no parking any time.

Sec. 114-3323. Holcomb Circle--Holcomb Avenue to dead end south of Holcomb Avenue.

Holcomb Circle, on the east side, from Holcomb Avenue to a point 65 feet south thereof, no parking any time.

Holcomb Circle, on the west side, from Holcomb Avenue south to and including any part of the cul-de-sac, no parking 8:00 a.m. to 4:00 p.m., Mondays.

Sec. 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.

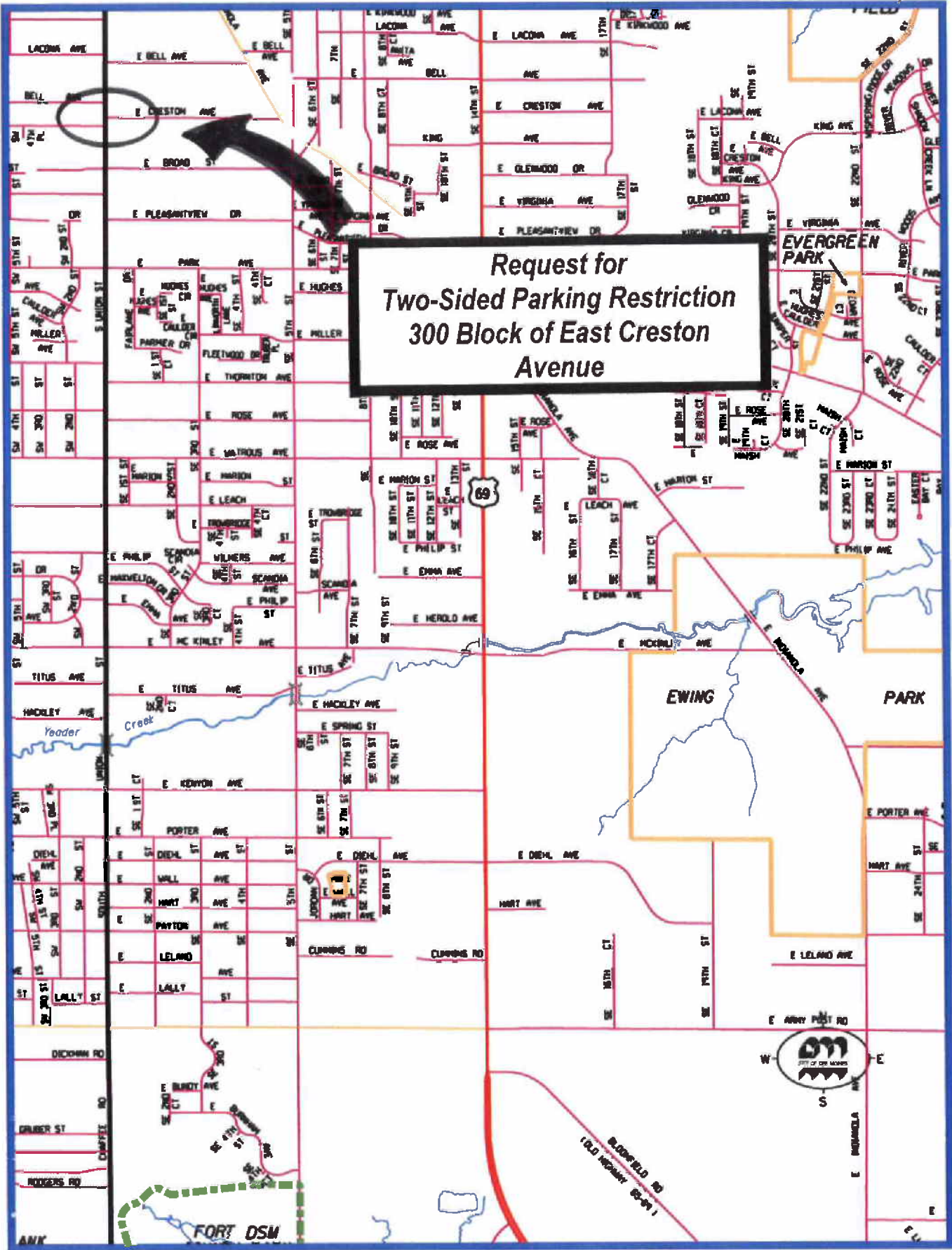

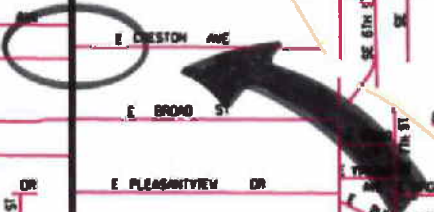

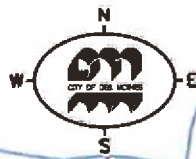
