SECOND AMENDMENT TO KIWANIS RIVERVIEW NATURE ISLAND 28E AGREEMENT

This Amendment is made and entered into this ______ day of _______, 2009, to that Kiwanis Riverview Nature Island 28E Agreement dated June 4, 2003 by and between the City of Des Moines, hereinafter called "City," whose address for the purpose of this Agreement is City Properties Administrator, 3226 University Avenue, Des Moines, Iowa 50311, and Kiwanis Riverview Nature Island Inc., hereinafter called "Kiwanis," whose address for the purpose of this Agreement is 1111 Ninth Street, Suite 180, Des Moines, Iowa 50314, hereinafter "28E Agreement" (Book 9896, Page 263).

WHEREAS, the City of Des Moines is the owner of certain real property, shown in Exhibit A locally known as Kiwanis Nature Island (aka Riverview Park), and the residence in McHenry Park adjoining the Kiwanis Nature Island locally known as 1012 Oak Park Avenue, Des Moines, Iowa (the "Oak Park Property"), (both properties together hereinafter the "Subject Properties").

WHEREAS, on June 6, 2003 by Roll Call No. 03-1241, the City and the Kiwanis entered into the 28E Agreement for the maintenance of the Subject Properties and the lease of the Oak Park Property; and

WHEREAS, on May 22, 2006, by Roll Call No.06-1020, the City and the Kiwanis entered into an Amendment to the 28E Agreement to extend the term of the 28E Agreement until June 1, 2009 (Book 11697, Page 540-542); and

WHEREAS, the City has determined that it is in the best interest of the City to extend the 28E Agreement for another eighteen (18) months and the Kiwanis have agreed to an eighteen (18) month extension.

NOW THEREFORE, in consideration of the mutual covenants, promises, and agreements hereinafter set forth, the parties agree as follows:

- 1. The term of the 28E Agreement shall extend until December 31, 2010.
- 2. All other terms of the 28E Agreement shall remain in effect.
- 3. This Second Amendment shall become effective upon its execution and filing with the Secretary of State as required in section 28E.8 Code of Iowa (2009).
