AN ORDINANCE vacating portions of excess street and alley rights-of-way located between 18<sup>th</sup> Street and 19<sup>th</sup> Street from Atkins Street to Day Street.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Section 1. That portions of excess street and alley rights-of-way located between 18<sup>th</sup> Street and 19<sup>th</sup> Street from Atkins Street to Day Street, more specifically described as follows, be and is hereby vacated.

Lot 6 and the South 10.0 feet of Lot 5, Butler's Addition, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa. and

All of the North/South alley right of way lying East of and adjoining the South 30 feet of Lot 37 and Lot 36, the North 20 feet of Lot 37 and Lot 38, Lots 39, 40, 41, and the South 20.0 feet of Lot 42, all in Butler's Addition, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.


