That the Finance Director be and is hereby authorized to draw the checks listed on the check registers for the weeks of May 22 and May 30, 2006; to draw the checks for the bills of the Des Moines Municipal Housing Agency to be presented to the Finance Director for the weeks of May 22 and May 30, 2006; and to draw the checks for biweekly payroll due employees of the City on May 26, 2006.
