WHEREAS, on April 16, 2001, by Roll Call No.. 01-1139 the City Council approved a 5 year lease agreement with the des Moines Power Boat Club; and

WHEREAS, the Des Moines Power Boat Club desires to continue to lease the below described real property for the storage of its club member's boats; and

WHEREAS, Park and Recreation Department staff and the Des Moines Power Boat Club have negotiated a Lease Agreement, a copy of which is on file in the City Clerk's Office, for an initial period from January 1, 2006 until December 31, 2010; and

**WHEREAS**, Des Moines Power Boat Club has agreed to pay a lease rental rate of \$1400.00 for year 1, \$1500.00 for year 2, \$16 00 for year 3, \$1700.00 for year 4 and \$1800.00 for year 5 of the lease plus 15% of the total gross receipts from the fees collected by the Club for boat storage.

WHEREAS, on May 8, 2006, by Roll Call No. 06-\_\_\_\_\_\_, it was duly resolved by the City Council that the proposed vacation of the below described portion of Birdland Park be set down for hearing on May 22, 2006, at 5:00 p.m., in the Council Chamber; and
