Bid item no. 2 was the estimated quantity of 500 SF was bid at by Platinum Builders at \$15.22 per square feet. After infrared photography, core sampling and tear out to dry material 2,461 SF of insulation was determined to be wet. A net add of 1,961 SF is added by this change order.
