APPROVING AND AUTHORIZING THE SUBMISSION OF A GRANT AMENDMENT TO THE IOWA DEPARTMENT OF ECOMOMIC DEVELOPMENT (IDED) COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) CONTRACT 08-DRI-205 FOR THREE ADDITIONAL EMERGENCY STORM WATER GENERATORS.

WHEREAS, the Iowa Department of Economic Development (IDED) has received U.S. federal funds under the Consolidated Security, Disaster Assistance, and Continuing Appropriations Act of 2009, (P.L. 110-329); and

WHEREAS, the City of Des Moines has applied to IDED and been awarded \$2,500,000 with the primary purpose of providing funding for infrastructure repair and construction to areas that meet defined eligibility criteria to benefit low and moderate income persons and families in the city of Des Moines in contract 08-DRI-205 for the purchase and installation of the original five (5) emergency generators; and

WHEREAS, after completion of detailed design, the estimate for the five emergency generators was revised to \$1.52 million, and staff is recommending submitting a grant amendment to IDED to add three (3) emergency storm water generators to the existing grant an estimate cost of \$1.1 million to fully utilize the approved grant funds. The three (3) additional emergency generator locations are at the 1813 2nd Avenue, 601 SW 5th Street, and 700 SW 7th Street pump stations, all of which are located in designated low to moderate income areas. The City will be responsible for all costs above the approved grant of \$2.5 million; and

WHEREAS, the City can fund any costs associated with the proposed emergency generators that would exceed the \$2,500,000 awarded under Contract 08-DRI-205.


