## PUBLIC HEARING AND APPROVAL OF THE PROPOSED AMENDMENT TO THE FOURTH YEAR(2008) ACTION PLAN OF THE 2005-2009 HUD CONSOLIDATED PLAN FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT RECOVERY (CDBG-R) PROGRAM

WHEREAS, on November 19,2007 by Roll Call 07-2231, the City Council held a public hearing and approved the proposed Fourth (2008) Year Action Plan of the 2005-2009 U.S. Department of Housing and Urban Development (HUD) Consolidated Plan; and

WHEREAS, under Title XII of the American Recovery and Reinvestment Act of 2009, Congress has designated additional financial assistance and services to local governments to carry out, on an expedited basis, eligible activities under the Community Development Block Grant program: and

WHEREAS, Congress has made funding available for the Community Development Block Grant Recovery program under Title XII of Division A of the American Recovery and Reinvestment Act of 2009, and referred to as CDBG–R; and

WHEREAS, grantees eligible to receive funds under the CDBG-R, including the City of Des Moines, are required to complete and submit to HUD a substantial amendment to the Fourth (2008) Year Action Plan of the 2005-2009 HUD Consolidated Plan; and

WHEREAS, the City's Fourth (2008) Year Action Plan requires that a public hearing be held to allow citizens to comment on the substantial amendment to the Consolidated Plan; and

WHEREAS, the substantial amendment to the Fourth (2008) Year Action Plan, on file with the City Clerk as Exhibit "A" and by this reference made a part hereof, allocates CDBG-R funds to eligible activities consistent with the overarching goals of the Recovery Act and the City of Des Moines' Consolidated Plan, including estimated budgets for these activities to be funded from \$1,152,886 of CDBG-R funds currently allocated to the City of Des Moines; and

WHEREAS, on May 18, 2009, by Roll Call 09-852, in order to provide a forum for public comment on the proposed substantial amendment to the Fourth (2008) Year Action Plan, and to comply with the local Consolidated plan citizen participation process, the City Council set a public hearing for a special meeting on June 3,2009; and

WHEREAS, the public hearing has now been opened and all persons seeking to express their views regarding the substantial amendment to the Fourth (2008) Year Action Plan of the 2005-2009 HUD Consolidated Plan have been afforded the opportunity to do so; and

BE IT FURTHER RESOLVED that, consistent with Roll Call No. 96-1034, dated March18,1996 regarding contract and amendment procedures for HUD Consolidated Plan projects, the City Council authorizes and directs the City Manager to approve and execute the detailed work programs and written agreements with sub-recipient entities implementing all programs contained in the Fourth (2008) Year Action Plan in accordance with City Council approval of the substantial amendment and the projects listed therein.

BE IT FURTHER RESOLVED that, consistent with Roll Call No. 96-1034, dated March 18, 1996 regarding contract and amendment procedures for HUD Consolidated Plan projects, all proposed amendments to work programs and written agreements with sub-recipient entities that are not in accordance with City Council approval of the Consolidated Plan, as amended, and the projects listed therein or that constitute a substantive change in the location, level of service, time period, budget or project purpose shall be submitted to the citizen review process and City Council for consideration and approval prior to execution by the City Manager.
