That if the City Council decides to vacate the above described right-of-way, the City of Des Moines proposes to sell such right-of-way, as described below, along with an irregular portion of excess Keosauqua Way right-of-way and Ascension Street West of and adjoining 14th Place, to the grantee and for the consideration identified below:


