Set Date of Public Hearing for Approval of a Commercial Operator Lease and Agreement with MidAmerica Jet Center for Services at the Des Moines International Airport

WHEREAS, the City of Des Moines, hereinafter called "City", owns an airport known as the Des Moines International Airport, located in Polk County, Iowa, hereinafter called the "Airport"; and

WHEREAS, on July 6, 1987, by Roll Call, 87-2826, City Council approved a twenty year Commercial Operator and Lease Agreement with Allied Mutual Insurance Company for a one acre parcel on the Airport to allow Allied Mutual to build a corporate hangar and related facilities to conduct commercial operations.

WHEREAS, on May 23, 1988, by Roll Call No. 88-2386, City Council accepted conveyance of the substantially completed property to the City of Des Moines.

WHEREAS, on September 20, 1993, by Roll Call No. 93-3490, the Des Moines City Council approved Ordinance 12,040 assigning certain rights and responsibilities pertaining to the Airport to the Des Moines International Airport Board (hereinafter called the "Airport Board"), including the right to enter into leases up to three years in duration and other certain agreements; and

WHEREAS, on January 3, 1995, by Roll Call No. 95-112, City Council approved the Assignment of Agreement from Allied Mutual Insurance Company to MidAmerica Transportation Inc, a/k/a MidAmerica Jet Center, Inc.; and

WHEREAS, the current Agreement is set to expire on June 30, 2007 under its own terms; and

WHEREAS, MidAmerica Jet Center and the Airport have reached agreement regarding the terms of a new Agreement; and

WHEREAS, Airport staff and MidAmerica Jet Center have determined that an Agreement with a ten year term would be most appropriate to address both parties' needs; and

WHEREAS, the Agreement is greater than three years and therefore requires approval by Des Moines City Council; and
