PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON 2006 PEDESTRIAN CROSSING CONTROL IMPROVEMENTS; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS BAKER ELECTRIC, INC., BRITT BAKER, CEO, \$153,900.26

WHEREAS, on May 7, 2007, under Roll Call No. 07-839, plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost were filed with the Chief Deputy City Clerk, for the construction of the following improvement:

2006 Pedestrian Crossing Control Improvements, 04-2006-012
CS-TSF-1945(717)--85-77

The improvement consists of upgrading five existing pedestrian crossing locations throughout Des Moines including the installation of pedestrian crossing signs with pushbutton-activated LED lights, a driveway relocation, installation of a pedestrian signal, and improved crosswalk markings in accordance with the contract documents including Plan File Nos. 472/110-117 at:

- University Avenue east of 29th Street
- University Avenue at 27th Street
- University Avenue at 4th Street
- E. Grand Avenue at E. 13th Street
- 2200 Block of Grand Avenue

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Jurisdictional Engineer's estimate of construction cost for said improvement.

BE IT FURTHER RESOLVED: That sealed bids for said improvement were submitted by the following bidders:

which were received and opened at a public meeting presided over by the Jurisdictional Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D. BE IT FURTHER RESOLVED: That the bid security of the unsuccessful bidders be and is hereby authorized and directed to be returned.


