## HONORABLE MAYOR AND MEMBERS OF THE DES MOINES CITY COUNCIL

Re: Report to Council

Pursuant to the authority and direction of Council authorizing the City Attorney to settle claims, lawsuits and workers compensation actions for a total sum not to exceed \$5,000, I submit to Council the following summary report of settlements made:

TMC AUTO BODY, 551.81 to repair damages to claimant's vehicle that was damaged on 1/25/09 when plow driver struck parked car at 1441  $41^{st}$  Place.

STANLEY COUSINS, \$897.55 in payment of claim of 1/25/09 when plow driver slid through a stop sign at Franklin and 47<sup>th</sup> Street and was hit by claimant who had right of way.

STEVEN PETTIS, \$4,048.00 for property damage regarding claim of 12/2/08 when sanitary sewer was obstructed at 1444 Richmond Avenue.

MIDAMERICAN ENERGY COMPANY, \$321.50 for damages to utility pole resulting from claim of 10/27/08 when police officer was on Hickman Avenue with lights and sirens activated and was struck by another driver at 30<sup>th</sup> Street; after the impact the officer backed into a utility pole.

JOHN MALONE, \$1,030.19 for repairs to claimant's vehicle resulting from incident of 12/15/08 when police officer rear-ended the car on Third Street at Court Avenue.

COREY HARVEY, 1,126.97 in payment of claim of 1/14/09 when snowplow's blade struck claimant's parked car at 3833 Lindlavista Way.

JANIS BUCHHOLZ AND TMC AUTO BODY, \$1,982.15 for repairs to claimant's vehicle that was parked at 7506 SW 13<sup>th</sup> Street on 1/25/09 and was struck by a City snowplow; ENTERPRISE RENT A CAR, \$432.86 for rental car expense.

JACK NORTHWAY, \$4,408.36 in payment of claim of 12/31/08 when Fire Department driver rearended vehicle at East 14<sup>th</sup> Street and University Avenue. JODEE LYNN WEDGEWORTH, \$1,135.37 in payment of claim of 1/3/09 when sander truck struck claimant's parked car at 1212 Shawnee.

DAWN M. STEWART, \$1,771.50 for property damage resulting from obstructed sewer on 11/28/08 at 1004 Euclid.

JILL TYLER, \$547.40 in payment of property damage claim of 12/29/08 when City plow driver struck claimant's vehicle at the intersection of  $62^{nd}$  and Muskogee.

KINMAN GLASS, \$57.00 to repair claimant's windshield resulting from incident of 1/27/09 when sander truck threw gravel into claimant's vehicle at East Euclid and East 14<sup>th</sup> Street.

MIDAMERICAN ENERGY COMPANY, \$1,734.00 in payment of claim of 12/19/08 when pick up arm of garbage truck caught guide wire and damaged the wire and metal supports on 33<sup>rd</sup> Street at Mondamin Avenue.

KAREN PETERS, \$430.05 for repairs of vehicle regarding claim of 1/7/09 when sander truck sprayed side of claimant's vehicle with sand and rocks while traveling on Army Post at Indianola Road; we previously paid \$1,177.90 for repairs for a total of \$1,607.95 for this claim.

ELVERSON, VASEY & PETERSEN, LLP TRUST FUND, \$1,625.00 in settlement of lawsuit regarding property damage related to a sewer backup on 2/10/07 at 102 S.W. 51<sup>st</sup> Street.

BAJRO KARIC, \$5,000.00 as an initial payment of claim regarding incident of 2/13/09 when City truck struck claimant's vehicle while attempting a U-turn in the 4200 block of Hickman; an additional payment will be requested at a council meeting.

NATHANIEL LAIR AND CHARLES GABUS FORD, \$2,538.71 in payment of claim of 1/25/09 when plow driver struck parked car in the 3700 block of Rollins Avenue.

MIKE AND GINNIE BELL, \$2,528.00 for property damage at 4113 East Boyd Street on 12/19/08 when sewer was obstructed with roots and caused backup.

DAVID HEGGEN and PAM CARMICHAEL, \$786.00 in payment of claim regarding incident of 12/30/08 when pick up arm of garbage truck struck garage and fence at 1504 Thompson Avenue.

JOHN ERICKSON, 30.00 to replace mailbox that was struck by garbage truck on 1/2/09 at 714 S.E. Diehl Street.
