APPROVING AND AUTHORIZING THE EXECUTION OF  
ADDENDUM 2001-P-028B TO IOWA DEPARTMENT OF TRANSPORTATION  
PREDESIGN AGREEMENT FOR THE RECONSTRUCTION OF I-235

WHEREAS, the City Council, by Roll Call 00-3624, on August 31, 2000, approved a Predesign Agreement with the Iowa Department of Transportation (IDOT) for I-235, from the west City limits to the north City limits; and

WHEREAS, the City Council, by Roll Call 02-2391, on October 7, 2002, approved an Addendum to the I-235 design and reconstruction Predesign Agreement with the IDOT that identified the responsibilities of the IDOT and City regarding the inspection and materials testing of sanitary sewer relocation and storm sewer outlet work; and


WHEREAS, a second Addendum 2001-P-028B to the I-235 design and reconstruction Predesign Agreement has been negotiated with the IDOT to delay two remaining loan repayments for a period of one-year each.


NOW, THEREFORE, BE, AND IT IS HEREBY RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the Addendum to Predesign Agreement No. 2001-P-028B, between the City of Des Moines, and the Iowa Department of Transportation for the I-235 design and reconstruction, be and is hereby approved, subject to approval by the Iowa Department of Transportation.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Addendum to Predesign Agreement for and on behalf of the City of Des Moines, Iowa, and the City Clerk is directed to return two original copies of said Agreement to the Engineering Department for transmittal to the Iowa Department of Transportation.
