SET HEARING ON THE VACATION OF PORTIONS OF SOUTHEAST 2ND STREET AND RACCOON STREET RIGHT-OF-WAY AND CONVEYANCE TO MIDAMERICAN ENERGY COMPANY FOR \$1

WHEREAS, on April 25, 2005, by Roll Call No. 05-969, the City Council of the City of Des Moines authorized the acquisition, by gift, negotiation, or condemnation, of the right-of-way required to construct the Southeast Connector Project – SW 2nd to SE 6th Street Phase ("Project"); and

WHEREAS, on September 24, 2007, by Roll Call No. 07-1829, the City Council established the fair market value of property interests located at 200 SE 3rd Street, Des Moines, Iowa 50309, and owned by MidAmerica Development Company and leased by MidAmerican Energy Company; and

WHEREAS, on March 10, 2008, by Roll Call No. 08-378, the City Council approved a Right-of-Way acquisition settlement agreement and accepted easements from MidAmerica Development Company and Mid American Energy Company, which settlement included the agreement that upon approval by the City Planning & Zoning Department, the City will vacate and convey to MidAmerican Energy a portion of SE 2nd Street valued at \$20,000.00 to be used by MidAmerican Energy for internal site access in lieu of MidAmerican Energy's request of compensation in the amount of \$90,247.00 for gates with card readers and a chain link fence; and

WHEREAS, the vacation of the portions of Southeast 2nd Street and Raccoon Street, hereinafter more fully described, and conveyance of a part thereof to MidAmerican Energy, will eliminate the need for public or private vehicular access to Southeast 2nd Street between Market Street and Raccoon Street and to Raccoon Street between Southeast 2nd Street and Southeast 4th Street, which allows for expansion and increased security of the City's Fleet Services operation; and

WHEREAS, on June 9, 2008, by Roll Call No. ______, the City Council adopted a recommendation from the City Plan and Zoning Commission that portions of Southeast 2nd Street and Raccoon Street, hereinafter more fully described, be vacated, including the part thereof to be transferred to MidAmerican Energy; and

WHEREAS, following said recommendation from the City Plan and Zoning Commission, the City may now vacate portions of Southeast 2nd Street and Raccoon Street, and convey the agreed-upon part thereof to MidAmerican Energy pursuant to the terms of the Right-of-Way acquisition settlement agreement.

All that part of Southeast 2nd Street right-of-way lying North of the easterly extension of the North right-of-way line of Raccoon Street and South of the easterly extension of the South right-of-way line of vacated East Elm Street vacated by Ordinance 9187, October 4th, 1976 and lying East of and adjoining Block A, Scott and Dean's Addition, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

and

All that part of Southeast 2nd Street right-of-way lying East of and adjoining Block A, Scott and Dean's Addition, an Official Plat, and all that part of Raccoon Street right -of-way lying East of the East Bank of the Des Moines and Raccoon Rivers and West of the southerly extension of the West right -of-way line of Southeast 4th Street, and lying South of and adjoining Blocks R, A, M, and Block 6, of said Scott and Dean's Addition, and lying South of Southeast 1st Street, Southeast 2nd Street and lying South of vacated Southeast 3rd Street, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.

2. That if the City Council decides to vacate the above described right-of-way, the City of Des Moines proposes to sell a portion of such right-of-way as described below, to the grantees and for the consideration identified below:


