DES MOINES TRAFFIC REGULATION CHANGES

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:

- A. Parking Restriction—South Side of Willowmere Drive West of SW 61st Street
- B. Corner Clearance—West Side of 51st Street South of Grand Avenue
- C. Loading Zone Extension—West Side of 6th Avenue South of Grand Avenue







AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,870 passed October 16, 2000, and Ordinance No. 14,669 passed July 9, 2007, by amending Sections 114-2642, 114-2943 and 114-3778, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 13,870 passed October 16, 2000, and Ordinance No. 14,669 passed July 9, 2007, is hereby amended by amending Sections 114-2642, 114-2943 and 114-3778, relating to

traffic and vehicle regulations, as follows:

Sec. 114-2642. Sixth Avenue--Locust Street to Grand Avenue.

Sixth Avenue, on the east side, from Locust Street to Grand Avenue, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Sixth Avenue, on the east side, from a point 70 feet north of Locust Street to a point 80 feet north thereof, commercial loading zone.

Sixth Avenue, on the west side, from a point 100 feet north of Locust Street to a point $\frac{105123}{1000}$ feet north thereof, commercial loading zone.

Sixth Avenue, on the west side, from Locust Street to a point 205223 feet north thereof, no parking 7:00 a.m. to 9:00 a.m. and 4:00 p.m. to 6:00 p.m.

Sixth Avenue, on the west side, from Locust Street to a point 205 feet north thereof, no parking, 4:00 p.m. to 5:00 p.m.

Sixth Avenue, on the west side, from a point $\frac{205223}{200}$ feet north of Locust Street to Grand Avenue, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Sec. 114-2943. Fifty-first Street--Welker Avenue to Aurora Avenue.

Fifty-first Street, on the east side, from Welker Avenue to Grand Avenue, no parking any time.

Fifty-first Street, on the west side, from a point 60 feet south of Robertson Drive to a point 60 feet north of Robertson Drive, no parking any time.

Fifty-first Street, on the west side, from a point 550 feet south of Grand Avenue to a point 275 feet south thereof, no parking any time. Fifty-first Street, on the west side, from Grand Avenue to a point 60175 feet south thereof, no parking any time.

Fifty-first Street, on the west side, from Harwood Drive to Pleasant Street, no parking any time.

Fifty-first Street, on the west side, from Franklin Avenue to Allison Avenue, no parking any time.

Fifty-first Street, on the west side, from Lincoln Avenue to Hickman Road, no parking any time.

Fifty-first Street, on the east side, from Hickman Road to Urbandale Avenue, no parking any time.

Fifty-first Street, on the west side, from Hickman Road to 120 feet north thereof, no parking any time.

Fifty-first Street, on the west side, from Douglas Avenue to Aurora Avenue, no parking any time.

Fifty-first Street, on the east side, from Douglas Avenue to a point 50 feet north thereof, no parking any time.

Fifty-first Street, on the east side, from Madison Avenue to a point 50 feet south thereof, no parking any time.

Fifty-first Street, on the east side, from Madison Avenue to a point 50 feet north thereof, no parking any time.

Fifty-first Street, on the east side, from Aurora Avenue to Twana Drive, no parking any time.

Fifty-first Street, on the east side, from Aurora Avenue to a point 50 feet south thereof, no parking any time.

Fifty-first Street, on the west side, from Bel-Aire Road to Crestmoor Place, no parking any time.

Sec. 114-3778. Willowmere Drive--Dead end north of Park Plaza Drive to Southwest Sixty-third Street.

Willowmere Drive, on the south side, from a point 280 feet north of Park Plaza and any part of the cul-de-sac to Southwest Twenty-third Street, no parking any time.

Willowmere Drive, on the north side, from a point 50 feet east of Fleur Drive to a point 50 feet west of Fleur Drive, no parking any time.

Willowmere Drive, on the north side, from Southwest Twentyninth Street to Southwest Thirtieth Street, no parking any time.

Willowmere Drive, on the south side, from a point 315 feet west of Southwest Sixty-first Street to a point 150 feet west thereof, no parking 8:00 a.m. to 5:00 p.m. Monday through Friday.

Willowmere Drive, on both sides, from Southwest Sixty-third

Street to a point 50 feet east thereof, no parking any time.

Sec. 2. This ordinance shall be in full force and effect from

and after its passage and publication as provided by law.
