WHEREAS, Sue Moss has requested the City's assistance in clearing title objections to the property located at and locally known as 1909 Jefferson Avenue and 2802 Mondamin Avenue; and

WHEREAS, the City of Des Moines has the following liens against the property resulting from violations at various other properties owned by Sue Moss that she would agree to pay:

1) The costs due in CE 32991 in the amount of \$9,036.36. This judgment would be released upon payment.

2) The costs due in CE 37066 are \$7,548.55. Partial release of this judgment would be filed as it stands against the properties located at 1909 Jefferson Avenue and 2802 Mondamin Avenue upon payment of \$4,500.

WHEREAS, the City of Des Moines has the following liens against the property resulting from violations at unrelated properties owned by Sue Moss and Sue Moss seeks to have these judgments released from title to the properties located at 1909 Jefferson Avenue and 2802 Mondamin:

- 1) The costs due in EQCE 49343 are \$13,475.06.
- 2) The costs due in EQCE 49463 are \$5,790.70.
- 3) Legal action remains pending in CE 46581.
- 4) Legal action remains pending in CE 44658.
- 5) Legal action remains pending in CE 50646.
- 6) Legal action remains pending in CE 50976.
- 7) Legal action remains pending in CI 3798.

WHEREAS, Sue Moss seeks to have these judgments released from title to the real estate only as they stand as a lien against the title to the real estate located at 1909 Jefferson Avenue and 2802 Mondamin Avenue in order to allow transfer of the title to the buyers of the properties; and

WHEREAS, the real estate transaction cannot occur unless judgments unrelated to the property are released.
