WHEREAS, Ahlers & Cooney, P.C. has submitted a billing for environmental services in connection with the acquisition of the DICO property in the amount of \$1,338.80; and

WHEREAS, the City Legal Department has audited said billing and has verified it to be correct and recommends payment.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, to forward the billing to the Finance Department, and that the Finance Director is hereby authorized and directed to issue a check in the amount of \$1,338.80 to Ahlers & Cooney, P.C.
