Resolution Approving Issuance of Certificate of Completion for the inPlay Building at 215 Watson Powell Jr. Way

WHEREAS, on November 20, 2006, by Roll Call No. 06-2311, the City Council approved an Urban Renewal Development Agreement with Nelson Development 14, L.L.C. WHEREAS, the Developer has completed the Improvements in substantial compliance with the approved Conceptual Development Plan and has requested the City issue a Certificate of Completion as evidence of satisfaction of the Developer's construction obligations under the Development Agreement; NOW THEREFORE,

BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

1. The City Council hereby finds and acknowledges that Developer has satisfied its obligation to complete the Improvements described above in substantial compliance with the approved Conceptual Development Plan and the requirements of the Development Agreement. This resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 205 of the Development Agreement, for the Improvements to the property at 215 Watson Powell Jr. Way, more specifically described as follows:

Lot 8, River Hills Plat 2, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa.
