WHEREAS, the Police Departments share of the match will come from asset forfeiture funds; and,

WHEREAS, the grant is for a three year period, from October 1, 2007 through September 30, 2010; and,

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the grant applications under the COPS Technology grant program is hereby approved, with the Mayor authorized to sign the application on behalf of the City, with the City Clerk to attest to the Mayor's signature, and the City Manager and his staff directed to take any and all steps necessary to timely file and execute such application and carry out the duties and conditions of the grant.
