APPROVAL OF PUBLIC WORKS DEPARTMENT PROCURMENT OF ONE REPLACEMENT AUTOMATED SIDE-LOADING REFUSE TRUCK FROM PETERBILT OF DES MOINES FOR \$199,859.00

WHEREAS, on May 7, 2007 unit # 737, an automated side-loading refuse truck, was destroyed by an electrical fire and now needs to be replaced; and

WHEREAS, Roll Call 07-468, dated March 12, 2007, approved the procurement of four (4) replacement side-loading refuse trucks from Peterbilt of Des Moines, 3445 Adventureland Drive West, Altoona, IA 50009, for use by the Solid Waste Division; and

WHEREAS, Peterbilt of Des Moines has agreed to supply the city with an automated side-loading refuse truck to replace unit # 737, at the original bid price of \$199,859.00, as approved by Roll Call 07-468; and

WHEREAS, the City Manager recommends that the procurement of one replacement refuse truck for the Solid waste Division be exempted from the competitive bidding requirements for good cause shown, pursuant to Section 2-710(a) of the Municipal Code of the City of Des Moines; and

WHEREAS, funding is available from PWK100101/Solid Waste Enterprise Fund;

NOW THEREFORE BE IT RESOLVED, that good cause has been shown to exempt the procurement of one refuse truck from the Procurement Ordinance competitive bidding requirements; and

BE IT FURTHER RESOLVED that the Des Moines City Council hereby accepts and approves the procurement of one replacement refuse truck for the Public Works Department from Peterbilt of Des Moines at \$199,859.00.
