AGENDA HEADING:

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:
 A. Parking Restriction Modifications—6th Avenue between Walnut Street and Locust Street.
 B. Parking Restriction Modifications—Grand Avenue East of 18th Street.

SYNOPSIS:

Approval of first reading of the Ordinance regarding the following traffic regulation changes.

FISCAL IMPACT:

Amount: Minor costs.

Funding Source: 2006-2007 Operating Budget, Page 84, Engineering Department Traffic & Transportation – Sign Installation and Maintenance, ENG100413.

ADDITIONAL INFORMATION:

- A. Traffic and Transportation has reviewed the parking on 6th Avenue between Locust Street and Mulberry Street, and noted several changes to the code for designating handicapped parking meters and one minor change of the operational hours of the parking meters to indicate the previous removal of a rush hour restriction. The following ordinance changes will implement the proper handicap meters and hours of operation.

Sec. 114-3881. Sixth Avenue--Walnut Street to Locust Street.

Sixth Avenue, parking meter 6-301, two-hour meter, 8:00 a.m. to 6:00 p.m., on the east side, is designated as a handicapped meter, and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sixth Avenue, parking meter 6-304, two-hour meter, 8:00 a.m. to 6:00 p.m., on the west side, is designated as a handicapped meter, and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Sixth Avenue, on the west side, from a point 220 feet north of Walnut Street to Locust Street, two-hour meters, ~~9:00~~ 8:00 a.m. to 6:00 p.m.

Sec. 114-2641. Sixth Avenue--Walnut Street to Locust Street.

~~Sixth Avenue, parking meter 6-301, on the east side, is designated as a handicapped meter, and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.~~

~~Sixth Avenue, parking meter 6-304, on the west side, is designated as a handicapped meter, and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.~~

~~Sixth Avenue, on the west side, from Walnut Street to a point 180 feet north thereof, no parking any time.~~

- B. In coordination with the construction of the Gateway Lofts at 17th and Grand, along with several other changes in this area, Traffic and Transportation has reviewed the existing parking ordinances. The following recommended changes will provide additional metered parking in this area, and will help support the new residential and retail development. The following ordinance changes will implement the additional parking meters and other parking restrictions.

Sec. 114-4015. Grand Avenue--Seventeenth Street to Eighteenth Street.

Grand Avenue, on the north side, from a point 30 feet west of Seventeenth Street to a point 270 300 feet west thereof, four-hour meters, 9:00 a.m. to 4:00 p.m.

Sec. 114-4014. Grand Avenue--Sixteenth Street to Seventeenth Street.

Grand Avenue, on the north side, from a point 35 feet west of Sixteenth Street to a point 150 25 feet east of Seventeenth Street, four-hour meters, 8:00 a.m. to 4:00 p.m.

Sec. 114-4003. Eighteenth Street--Grand Avenue to Ingersoll Avenue.

Eighteenth Street, on the east side, from a point 35 feet north of Grand Avenue to a point 70 feet north thereof, ~~four~~ two-hour meters, 8:00 a.m. to 6:00 p.m.

Sec. 114-4002.01 Seventeenth Street--Grand Avenue to Ingersoll Avenue.

Seventeenth Street, on the west side, from a point 18 ft. north of Grand Avenue to a point 49 ft. north thereof, four-hour meters, 9:00 a.m. to 6:00 p.m.

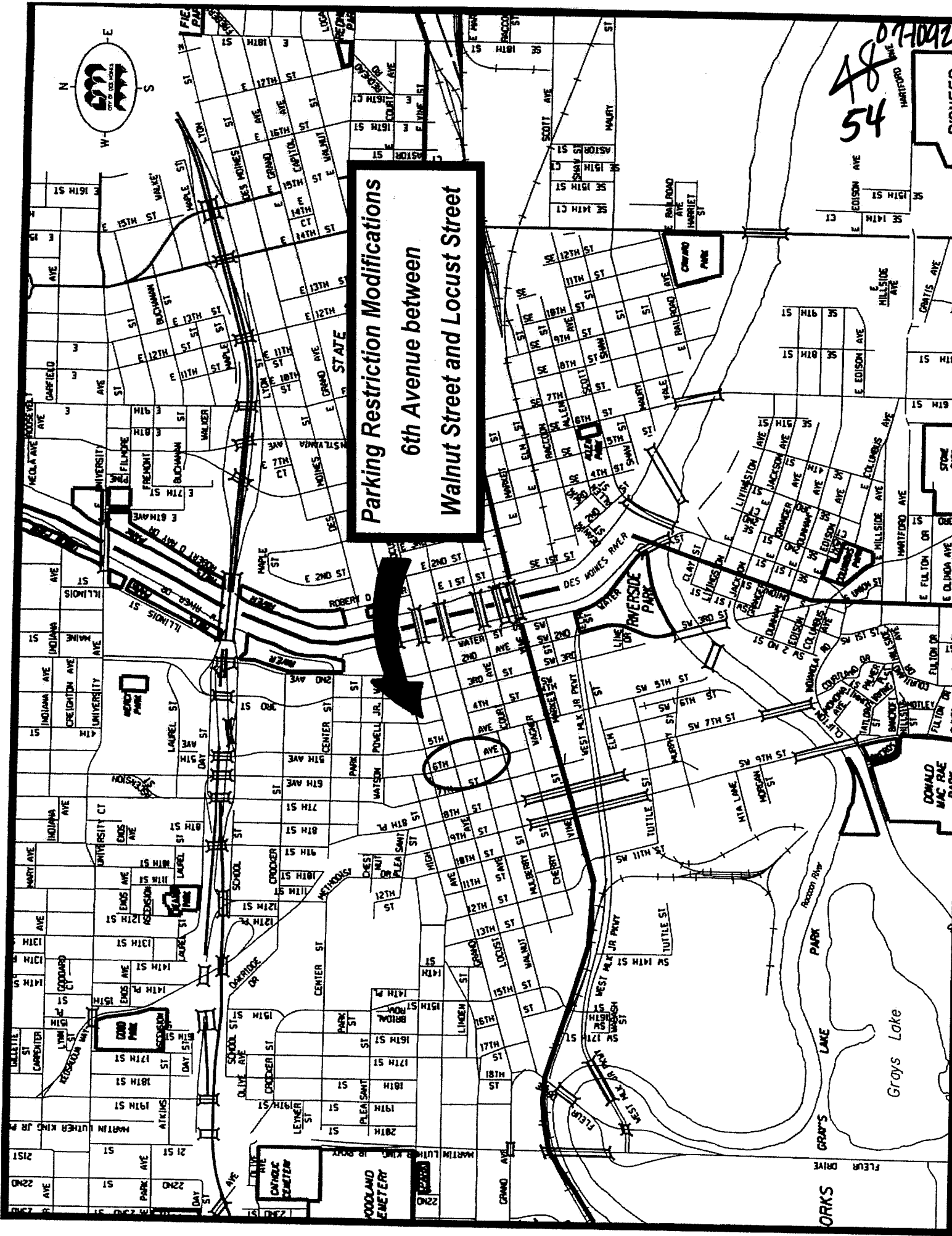

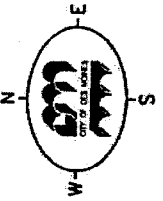

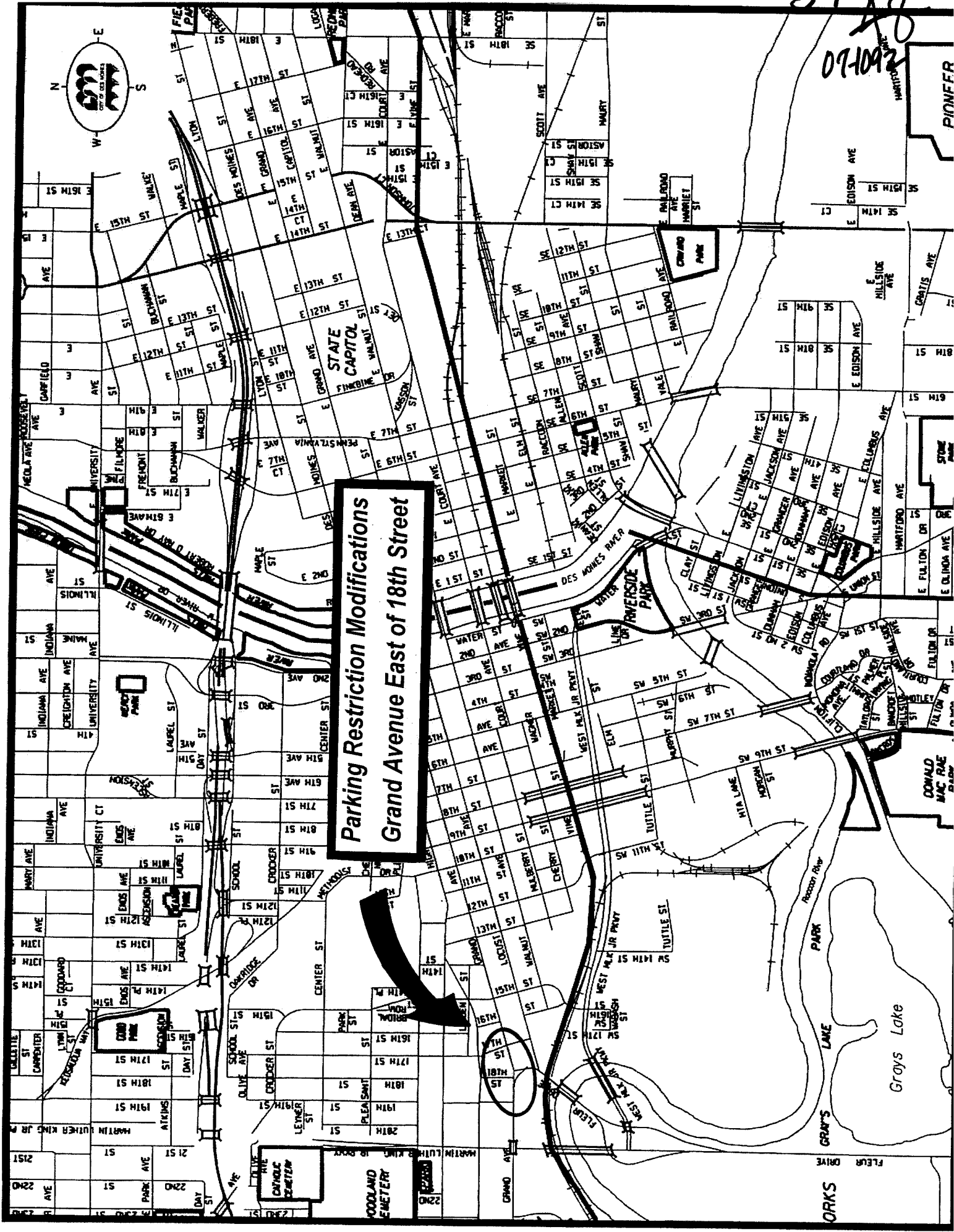
