Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, and amended by Ordinance No. 14,606 passed November 6, 2006 is hereby amended by amending Section 74-184 relating to fees at the Brenton Skating Plaza, as

#### AGENDA HEADING:

Brenton Skating Plaza facility rental fees for non-skating season

#### SYNOPSIS:

Recommendation to the Des Moines City Council to amend Chapter 74 of the City Code to add rental fees for the non-skating season at the Brenton Skating Plaza. The income generated through promoting the uses accommodated by these fees helps reduce the subsidy.

## **ADDITIONAL INFORMATION:**

On April 24 2007, the Des Moines Park and Recreation Board recommended approval to amend Chapter 74 of the City Code to add rental fees for the non-skating season at the Brenton Skating Plaza.

The City of Des Moines has entered into an agreement with the Riverfront Development Authority (RDA), which was approved by the Des Moines City Council on September 25, 2006, by Roll Call No. 06-1928, for the management, operations and maintenance of the Brenton Skating Plaza. The agreement is for a three-year term with one two-year renewal.

Within the terms and conditions of the agreement, RDA advised the City that it intends to contract with Rink Management Services (RMS) as the Skating Plaza operator. Additionally, the contract states; "The RDA shall operate the Skating Plaza open to the public and subject to, and in compliance with, the Municipal Code of the City of Des Moines and all City rules and regulations pertaining to parks, including setting hours, rules and regulations as with other City parks." Additionally, the contract states; "All fees and charges shall be established by the City. When setting such fees, the City Council shall take into consideration the RDA's recommendations regarding fees. In the event that the City Council does not adopt the RDA's recommendations regarding fees, the RDA shall have the right to terminate this Agreement upon written notice to the City effective upon ninety (90) days of receipt of such notice. The RDA shall have thirty (30) days from such City Council action in which to exercise such right to terminate or such right will be deemed waived. The RDA shall honor reduced skating admissions or skating lessons scholarship cards if issued by the City's Park and Recreation Department."

As a part of the operating costs, the RDA agrees to provide operating support in the amount of \$25,000, the City shall contribute up to \$25,000 and the RDA shall seek an additional \$25,000 contribution from the Downtown Community Alliance (DCA) during the term of the Agreement to subsidize the operations of the Brenton Skating Plaza. Any deficiency beyond the support identified above shall be borne by the RDA.

The RDA is proposing the following fees and charges for use of the Brenton Skating Plaza during the non-skating season:

Park and Recreation Department staff has reviewed the recommendation from Rink Management Systems and supports the proposed fee schedule. In comparing the proposed fee schedule with the Simon Estes Amphitheater, the City charges \$500.00 for four hours for a Free Public Event plus \$100.00 for each hour thereafter.
