SETTING DATE OF HEARING FOR AUTHORIZATION OF REAL ESTATE CONTRACT FOR PROPERTY LOCATED IN THE VICINITY OF SW MCKINLEY AVENUE BETWEEN SW 42ND STREET AND SW 56TH STREET FROM THE CLAIRE F. CARLSON MARITAL TRUST AND THE CLAIRE F. CARLSON FAMILY TRUST IN THE AMOUNT OF \$5,900,000 FOR THE AIRPORT 13R/31L RUNWAY PROJECT

WHEREAS, On March 7, 2005, by Roll Call 05-541, the City Council of the City of Des Moines, Iowa, authorized the acquisition of all necessary property interests by gift, negotiation or condemnation for the Airport Runway 13R/31L Project; and,

WHEREAS, it has been proposed that the City acquire approximately 268 acres of real estate from the Claire F. Carlson Marital Trust and the Claire F. Carlson Family Trust for property located in the vicinity of SW McKinley Avenue between SW 42nd Street and SW 56th Street for the Airport 13R/31L Runway Project; and,

WHEREAS, a Purchase Agreement has been negotiated by and between the City and the said Sellers pursuant to which the City would purchase said real estate pursuant to an installment arrangement whereby the City would pay the purchase price of \$5,900,000 as follows:

- a) The sum of \$4,163,400 to be paid by the City to the Seller on or about July 15, 2006.
- b) The balance of \$1,736,600 to be paid by the City to the Seller on or about July 15, 2007; and,

WHEREAS, the City has been advised that such an arrangement constitutes a loan agreement under Section 384.24A of the Iowa Code, and that prior to authorizing such an agreement the City is required, pursuant to Section 384.83 of the Iowa Code, to publish notice of the proposal and of the date and time of the meeting at which the Council proposes to discuss and then take action thereon, and to receive oral and written objections thereto from any resident or property owner of the City; and,

WHEREAS, 95% of the cost of this property acquisition will be paid with a multi-year grant from the Federal Aviation Administration and the remainder of the costs to be paid with net revenues of the Des Moines International Airport.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa:

Section 1. That the Council meet in the Council Chambers, City Hall, Des Moines, Iowa at 5:00 p.m., on the 10th day of July, 2006, for the purpose of discussing and taking additional action concerning the authorization of a loan agreement, in the form of a Purchase Agreement in the amount of \$5,900,000 for the purpose of acquiring the property mentioned above.

Section 2. PUBLIC NOTICE is hereby given that the City Council of the City of Des Moines, Iowa, will hold a public hearing on the 10th day of July, 2006, at 5:00 p.m., in the Council Chambers, City Hall, Des Moines, Iowa, at which meeting the Council proposes to discuss and take additional action concerning the authorization of a proposed Purchase Agreement with the Claire F. Carlson Marital Trust and the Claire F. Carlson Family Trust (herein referred to as Sellers), for the purchase of real estate consisting of approximately 268 acres located in the vicinity of SW McKinley Avenue Between SW 42nd Street and SW 56th Street.

This Agreement, if authorized by the City, would require the City to pay the \$5,900,000 purchase price in installments, as follows:

- c) The sum of \$4,163,400 to be paid by the City to the Seller on or about July 15, 2006.
- d) The balance of \$1,736,600 to be paid by the City to the Seller on or about July 15, 2007.

The purchase price for this property shall be payable from the net revenues of the Des Moines International Airport.

At the above meeting, the Council shall receive oral or written objections from any resident or property owner of the city to the above action. After all objections have been received and considered, the Council may at this meeting, or at any adjournment thereof, in accordance with Section 384.24A(5) and section 384.83 of the Iowa Code, take additional action for authorization to execute said Purchase Agreement to purchase the real estate described above.


