Resolution Approving Section 108 Loan Guarantee Application and Amended Brownfield Economic Development Initiative (BEDI) Grant Application for Redevelopment of Riverpoint West.

WHEREAS, on October 24, 2005, by Roll Call No. 05-2603, the City Council approved the Preliminary Terms of Agreement for redevelopment of the Riverpoint West Area with River Point West, LLC, an affiliate of both Sherman Associates, Inc. (George Sherman, President); and.

WHEREAS, subject to receipt of the public assistance identified below, River Point West, LLC intends to redevelop the Riverpoint West Area located south of Martin Luther King Jr. Parkway and west of SW 9th Street with 642 townhomes/condominiums, 384,000 square feet of commercial space and other improvements with an estimated market value of \$165 million and a six-year build-out; and,

WHEREAS, under the terms of the Preliminary Agreement the City undertook to contract for professional services with a consultant to assist the City in analyzing the structure of the deal, identifying other financing options, and preparing a U.S. Department of Housing and Urban Development (HUD) Section 108 Loan application and amended Brownfields Economic Development Initiative (BEDI) application to partially fund the public assistance to the project; and.

WHEREAS, the City staff, with assistance from a consultant from the National Development Council, has prepared applications for a Section 108 loan in the amount of \$17.5 million, and to re-program an existing Brownfield Economic Development Initiative (BEDI) grant in the amount of \$2 million to assist in the commercial redevelopment of the Riverpoint West Area; and,

WHEREAS, the Section 108 loan funds will be used primarily for land acquisition, environmental remediation, geo-technical work and infrastructure installation, and the BEDI grant will fund a debt service reserve account to repay the Section 108 loan during the first five vears of the loan term; and,

WHEREAS, the City Manager recommends that the City Council approve the Section 108 loan and BEDI grant applications, with final approval and acceptance of the loan and grant to be subject to reaching an acceptable final development agreement with River Point West, LLC; NOW THEREFORE,
