RESOLUTION APPROVING FIRST AMENDMENT TO AGREEMENT FOR ASSIGNMENT OF TAX SALE CERTIFICATES TO S & G REAL ESTATE INVESTMENTS, INC.

WHEREAS, Iowa Code 446.19A permits cities to acquire tax sale certificates for abandoned property assessed as residential property or as commercial multifamily property at a tax sale without paying the taxes then due, to obtain the assignment of outstanding tax sale certificates by payment to the holder the amount then due to redeem the certificate, and to give notice of expiration of the redemption period upon an expedited schedule, all for the purpose of encouraging the acquisition and rehabilitation of abandoned dwellings; and,

WHEREAS, on October 10, 2005, by Roll Call No. 05-2455 City Council approved the assignment of the 2005 tax sale certificate for the property described below to S&G Real Estate Investments, Inc. ("S & G Real Estate"), an Iowa for-profit corporation represented by Paul Gengler, President, and it has successfully obtained the tax deed for the property in accordance with Iowa Code 446.19A; and

WHEREAS, S&G Real Estate has had the home inspected by a registered engineer and is requesting that the agreement be amended to allow the property described below to be demolished and a new single family dwelling(s) be built on the lot for re-sale for owner-occupied housing;

WHEREAS, the City and S & G Real Estate proceeded under the requirements of 446.19A in the belief the existing dwelling could be rehabilitated for single family residential use, but it has now been determined after further investigation that it is neither feasible or reasonable to renovate the dwelling; and,

WHEREAS, it is in the best interest of the City to allow S & G Real Estate to demolish the existing dwelling and to construct one or two new single-family dwellings upon the property; NOW THEREFORE,
