

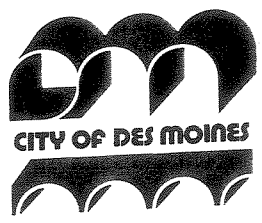

Please be advised that based upon a recommendation of the Des Moines Police Department, I have denied your application for a Limousine Driver's License. This denial is based on your criminal record, which does not meet the requirements for obtaining a Limousine Driver's License.

According to the Police Department records, the following activity occurred:

Criminal Record:

04/30/2004 Arrested on charge of OWI 1st. On 1/27/05 found guilty on reduced charge of Public Intoxication.

This record does not meet the requirements for good moral character as required by the City of Des Moines Municipal Code. Therefore, your application for a Limousine Driver's License is denied under Municipal Code Section 126-70.2 (b-2, I, iii). A copy of this section of the code is enclosed for your information.

If you desire to appeal this matter, you may request a hearing before the Des Moines City Council by filing a written appeal with the City Clerk within ten (10) days of receiving this letter. If you do appeal this matter, your background information will be provided to the City Council and you must appear at the designated hearing for your appeal to be considered. You must also provide a letter from the Limousine Company that they will allow you to drive for them.

Now on 1-22-07, Defendant having previously plead guilty on 8-12-07, 20__ appears in person and with counsel, TREUER WINK on the charge(s) of: PUBLIC INTELLECTUAL PROPERTY in violation of Iowa Code Section(s) 123.46

At the time of sentencing, Defendant was afforded an opportunity to speak in mitigation of the sentence. The sentence given here is made after considering the protection of the public, the maximum opportunity for rehabilitation of the Defendant, the Defendant's prior record, if any, and the statutorily imposed sentence requirements, if any. Based upon these considerations the following sentence imposed here is appropriate.

Defendant is ordered to obey all laws while on probation whether they be Federal, State or City laws or ordinances. Defendant is to notify his/her probation supervisor immediately upon any arrest, or change of address. Failure to comply with the terms of this probation may result in revocation of probation and imposition of the original sentence or a finding of Contempt of Court for which Defendant could receive up to six months in jail, a \$500 fine, or both. Court costs are assessed against Defendant.

If judgment was not deferred, Defendant has a right to appeal this judgment to the Iowa Supreme Court.
