WHEREAS, the Fire Department wishes to utilize all three proposals received to allow for item by item comparison of best price and delivery time to the best advantage of the City; and

WHEREAS, bids were received from Bound Tree Medical, 5200 Tuttle Crossing Blvd., Dublin, OH 43016, Moore Medical, 1690 New Britain Ave, Farmington, CT 06032, and Midwest Medical Supply, 13400 Lakefront Drive, Earth City, MO 63045; and

WHEREAS, funding is available from FIR041000, Emergency Medical Services, for an annual estimated cost of \$145,000; and

WHEREAS, the Procurement Administrator and the Fire Department recommend approval of multiple awards for medical and pharmaceutical supplies.

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to the aforementioned bidders, and further authorizes the Procurement Administrator to enter into annual agreements renewable for two (2) additional twelve (12) month periods.
