Resolution No. 09-050 Dated: May 26, 2009

NOW, THEREFORE, BE IT RESOLVED by the City of Des Moines Park and Recreation Board that:

An ordinance governing public dance and prohibiting public dancing without first obtaining a permit and during certain hours has been part of City Code since at least 1942. This ordinance appears to be rather unique. Other local units of government in lowa and across the United States are able to insure the public safety and welfare without the need to single out for regulation this constitutionally recognized form of free expression; and

The Parks and Recreation Board is confident that other laws and regulations governing conduct on property under Parks and Recreation jurisdiction are more than adequate to insure the safe and proper use of the city's parks and recreational facilities. This board can find no public purpose for singling out dancing from other types of gatherings for regulation; and

Moreover, the dance ordinance projects an image that is inconsistent with the image the Park and Recreation Board wishes to project for the City of Des Moines. Our desire is to see public property freely utilized by citizens wishing to exercise their constitutional rights of assembly and expression free of unnecessary regulations; and

We believe that dancing is a natural and fundamental form of human expression that enhances use of city property. This ordinance reflects poorly on the city and harms our efforts to project the city as forwarding thinking, tolerant and supportive of an attractive cultural environment, all of which we believe are critical in retaining and attracting a creative workforce so vital to our economic development efforts; and

There appears to be widespread misunderstanding and non-compliance with the ordinance. There are currently only twenty-nine valid dance permits while many, many more organized public dances are held every year within the City of Des Moines without the enforcement of the dance ordinance by the City of Des Moines Police Department. There has been, however, at least one instance this year in which the Police Department has enforced this ordinance and prevented a public dance.

For these reasons and others, we would encourage the City Council to review this ordinance in its entirety and we would specifically request that property under jurisdiction of the Parks and Recreation Department be exempt from Article III of City Code Chapter 14 (Public Dances).
