APPROVING AND AUTHORIZING THE EXECUTION OF AMENDMENT NO. 1 TO THE UNITED STATES DEPARTMENT OF AGRICULTURE NATURAL RESOURCES CONSERVATION SERVICE PROJECT AGREEMENT FOR THE EMERGENCY WATERSHED PROTECTION PROGRAM FOR 1706 PENNSYLVANIA AVENUE SLOPE STABILIZATION

WHEREAS, on September 22, 2008 by Roll Call No. 08-1662, Council authorized and directed the City Manager to make application with the United States Department of Agriculture (USDA) for assistance under its Emergency Watershed Protection (EWP) Program for certain property owners in the City of Des Moines who experienced issues with land sliding on their property resulting from the flooding and rain conditions of 2008; and

WHEREAS, said application was made and funding pursuant to the USDA's EWP Program is available for construction of slope stabilization on the property located at 1706 Pennsylvania Avenue, Des Moines, Iowa and owned by Steven C. Wallace and Alyce A. Wallace; and

WHEREAS, on February 23, 2008, by Roll Call No. 09-281, Council authorized and directed the Mayor to execute the agreement between the City and Steven C. Wallace and Alyce A. Wallace regarding the City's sponsorship to obtain financial assistance through the EWP Program with the USDA Natural Resource Conservation Service (NRCS) for the property; and

WHEREAS, the City's Legal Department and the Real Estate Division of the Engineering Department has acquired the necessary easements for this project; and

WHEREAS, the USDA-NRCS has approved use of the EWP funds for repairs for 1706 Pennsylvania Avenue, and the total estimated cost of the project is \$170,000.00, of which the EWP Program will fund 75% of the project cost with 25% local share paid per agreement with the property owners; and

WHEREAS, on May 4, 1009, the City Council authorized the execution of the Cooperative Project Agreement (Locally Led Contracting) and attachments thereto, and the Operation and Maintenance Agreement and Plan, for the 1706 Pennsylvania Avenue project; and

WHEREAS, due to funding requirements, the USDA-NRCS had required an initial Project Completion Date of June 22, 2009, and recommended that the City submit a written request for an extension of said Project Completion Date along with the Council-approved EWP Program agreements; and

WHEREAS, the City has now received Amendment No. 1 extending that Completion Date from June 22, 2009 to December 31, 2009.
