## MOTION CONTINUING HEARING ON APPEAL BY TRAFALGAR HOLDINGS FROM DENIAL OF A CERTIFICATE OF APPROPRIATENESS FOR A TWO-CAR GARAGE AT 1520 CENTER STREET
