## HOLD HEARING FOR CONVEYANCE OF EXCESS CITY-OWNED PROPERTY LOCATED AT 405 SE 8<sup>TH</sup> STREET TO JESSE AND MARJORIE L. CORTEZ BY LAND EXCHANGE

WHEREAS, on November 26, 1990, the City of Des Moines acquired real property located at 405 SE 8<sup>th</sup> Street for corridor preservation for the SE Connector Project, which property is legally described below and is 3920 square feet in area with an approximate value of \$8,000 as determined by the City's Real Estate Division, and the City of Des Moines also owns property to the south located at 413 SE 8<sup>th</sup> Street which is part of the SE Connector right-of-way; and

WHEREAS, on April 25, 2005, by Roll Call No. 05-969, the City Council provided authorization to proceed with the acquisition of the necessary right-of-way and easements for the SE Connector Project from Southeast 2<sup>nd</sup> Street to Southeast 14<sup>th</sup> Street; and

WHEREAS, Jesse Cortez and Marjorie L. Cortez are the owners of property located at 407 SE 8<sup>th</sup> Street in between and adjoining both above-stated City-owned properties, the south half of which is 3920 square feet in area with an approximate value of \$8,000 as determined by the City's Real Estate Division; and

WHEREAS, City staff and Jesse and Marjorie Cortez have negotiated a land exchange by which the City will convey 405 SE 8<sup>th</sup> Street to the Cortez' for incorporation into their existing property in exchange for the Cortez' conveyance to the City of the south half of the property locally known as 407 SE 8<sup>th</sup> Street, which is required for the SE Connector Project; and

WHEREAS, the properties to be exchanged are equal in value, the City has no current or anticipated public need for the property locally known as 405 SE 8<sup>th</sup> Street to be conveyed to Jesse and Marjorie Cortez and will not be inconvenienced by the sale of said property, and the City will be benefited by the acquisition of the south half of the property locally known as 407 SE 8<sup>th</sup> Street, which is required for the SE Connector Project; and

WHEREAS, on June 14, 2010, by Roll Call No. 10-899, it was duly resolved by the City Council that the proposed conveyance of excess City-owned property by land exchange to Jesse and Marjorie L. Cortez be set down for hearing on June 28, 2010, at 5:00 p.m., in the Council Chambers; and


WHEREAS, due notice of said proposal to convey excess City-owned property was given as provided by law, setting forth the time and place for hearing on said proposal; and
