## HOLD HEARING FOR APPROVAL OF PROPOSED LEASE OF CITY-OWNED PROPERTY IN THE LOWER LEVEL OF THE 7<sup>th</sup> AND GRAND AVENUE PARKING GARAGE TO YOUTH AND SHELTER SERVICES, INC. FOR \$1,389.00 PER MONTH

WHEREAS, the City of Des Moines owns real property locally known as 701 Grand Avenue ("Property"), more particularly described below:

Space No. W-1 W-2, W-3 and W-4 Leasehold Site Improvements Lots 1, 2 and 3, Block F, Grimmels Addition, an Official Plat, all now included in and forming a part of the City of Des Moines, Polk County, Iowa; and

WHEREAS, Youth and Shelter Services, Inc. has offered to lease the Property from the City for operation of their Iowa Homeless Youth Centers (IHYC) program for a term of three years, with the option to renew for two additional three-year terms, subject to a ninety-day termination option for both parties, and payment of \$1,389.00 per month for the initial period, which amount represents fair market rent as currently determined by the City's Real Estate Division, with rent increases for each subsequent option period; and

WHEREAS, the City of Des Moines has no immediate or short term municipal purpose or use for the Property, and it is in the best interest of the City to enter into the Lease Agreement with Youth and Shelter Services, Inc., which agreement is on file with the City Clerk; and

WHEREAS, on June 14, 2010, by Roll Call No. 10-904, it was duly resolved by the City Council that the proposed lease of the City-owned Property be set down for hearing on June 28, 2010, at 5:00 p.m. in the Council Chambers; and


WHEREAS, due notice of said proposal to lease the Property was given as provided by law, setting forth the time and place for hearing on said proposal; and
